

DEFINITIONS

BEINNING

Poisonous Substance	Products that are classified under the poisons schedule are a poisonous substance. The proportion of the poison in the product will determine its numerical classification.
Hazardous Substance	Products are considered to be Hazardous if they pose an intrinsic risk to human or environmental health, such as mutagens (able to change DNA), teratogens (able to result in birth defects), carcinogens (able to generate cell abnormalities), etc. Materials are not hazardous substances if they pose risks such as potential for misuse, like flammability, or explosions when heated and ignited.

4. FIRST AID MEASURES

Ingestion

If swallowed, DO NOT induce vomiting. Keep at rest. Seek immediate medical attention.

Eye Contact

Flush eyes with large amounts of water until irritation subsides. Seek immediate medical attention.

Skin Contact

Flush area with large amounts of water and wash area with soap if available. Remove contaminated clothing, including shoes, and launder before reuse. Seek medical attention for skin irritations.

Inhalation

Using proper respiratory protection, immediately remove the affected victim from exposure. Administer artificial respiration if breathing is stopped. Keep at rest. Seek immediate medical attention.

First Aid facilities

Provide eye baths and safety showers.

Medical Attention

Treat according to symptoms. Avoid gastric lavage: risk of aspiration of product to the lungs with the potential to cause chemical pneumonitis.

6. ACCIDENTAL RELEASE MEASURES

Emergency Procedures

Prevent fluid from escaping to drains and waterways. Contain leaking packaging in a containment drum. Prevent vapours from building up in confined areas. Ensure that drain valves are closed at all times. Clean up and report spills immediately.

Methods and materials for containment

Major Land Spill

- Eliminate sources of ignition.
- Warn occupants of downwind areas of possible fire and explosion hazard.
- Prevent liquid from entering sewers, watercourses, or low-lying areas.

- Keep the public away from the area.
- Shut off the source of the spill if possible and safe to do so.
- Advise authorities if substance has entered a watercourse or sewer or has contaminated soil or vegetation.
- Take measures to minimise the effect on the ground water.
- Contain the spilled liquid with sand or earth.
- Recover by pumping use explosion proof pump or hand pump or with a suitable absorbent material.
- Consult an expert on disposal of recovered material and ensure conformity to local disposal regulations.
- See "First Aid Measures" and "Stability and Reactivity"

Major Water Spill

- Eliminate any sources of ignition.
- Warn occupants and shipping in downwind areas of possible fire and explosion hazard.
- Notify the port or relevant authority and keep the public away from the area.
- Shut off the source of the spill if possible and safe to do so.
- Confine the spill if possible.
- Remove the product from the surface by skimming or with suitable absorbent material.
- Consult an expert on disposal of recovered material and ensure conformity to local disposal regulations.
- See "First Aid Measures" and "Stability and Reactivity".

7. HANDLING AND STORAGE

Precautions for safe handling

This product is flammable. Do not open near open flame, sources of heat or ignition. No smoking. Keep container closed. Handle containers with care. Open slowly to control possible pressure release. Use grounding leads to avoid discharge (electrical spark). Avoid inhalation of vapours and use only in a well ventilated place. Observe good industrial hygience practices.

Conditions for safe storage

Store in a cool, dry place away from direct sunlight. Do not pressurise, cut, heat or weld containers - residual vapours are flammable. This product is flammable and will fuel a fire in progress.

Incompatible materials

Natural Rubber, Butyl Rubber, EPDM, Polystyrene, oxidants, chloroform, bromoform and other organic solvents.

8. EXPOSURE CONTROLS: PERSONAL PROTECTION

National Exposure Standards

The time weighted average concentration (TWA) for this product is: 445 mg/m³ (150 ppm), which means the highest allowable exposure concentration in an eight-hour day for a five-day working week. The short-term exposure limit (STEL) is: 890 mg/m³ (300 ppm), which is the maximum allowable exposure concentration at any time. Products may be identified as skin sensitisers, indicated as (Sen), which means that the product will induce ever-increasing adverse effects with subsequent exposure, such as loss of feeling in extremities, or pain or irritation on contact with the product. Where (Sk) appears, the product will be easily absorbed to the skin, risking overexposure and symptoms similar to Ingestion or Inhalation. applies in this case. Engineering Controls: Ventilation

The use of local exhaust ventilation is recommended to control process emissions near the source. Laboratory samples should be handled in a fume hood. Provide mechanical ventilation of confined spaces. Use explosion-proof ventilation equipment.

Respiratory Protection: Where concentrations in air may exceed the limits described in the National Exposure Standards, it is recommended to use a half-face filter mask to protect from overexposure by inhalation. A type "A" filter material is considered suitable for this product.

Eye Protection: Always use safety glasses or a face shield when handling this product.

11. TOXICOLOGICAL INFORMATION

Acute Effects

Ingestion

This product may harmful following ingestion. Large amounts of this product will result in central nervous system effects such as: headaches, dizziness, hallucinations, euphoria, tingling of the extremities, vomiting, and possibly loss of consciousness.

Eye Contact

High vapour concentrations produce conjunctiva irritation. This product can cause corneal burns.

Skin Contact

This product is easily absorbed to the skin and produces dryness and cracking after prolonged contact.

Inhalation

High vapour concentrations are irritating to respiratory system and may cause central nervous system effects such as dizziness, headaches, nausea, vomiting and loss of appetite.

Chronic Effects

Repeated of prolonged ingestion of this product could result in liver or kidney damage. Causes slight foetotoxicity but effects are seen only at high doses.
