

# The Grand Appeal, Gromit Unleashed 2 Sculpture Raffle 2018 – Win Tropi-canis!

## Terms and Conditions

1. Participation in this raffle costs £2.50 per raffle ticket.
2. Monies raised by this raffle will support the general work of Wallace & Gromit's Grand Appeal, Registered Charity No 1043603.
3. No ticket can be sold to, on behalf of, or for a person under the age of 16 years. If a ticket is sold unknowingly to, on behalf of, or for a person under the age of 16, they will be exempt from the raffle and will forfeit the prize.
4. The raffle is open to all mainland Great Britain residents aged 16 and over (this excludes Northern Ireland, Isle of Man and Channel Islands owing to Gambling Commission legislation). If persons from outside mainland Great Britain attempt to enter the raffle, their entry will be considered void.
5. Trustees and employees of The Grand Appeal, and their relatives, are ineligible to enter this raffle. Any tickets bought in the name of The Grand Appeal trustees, employees or relatives will be rejected from the draw and considered as donations to The Grand Appeal.

The receipt/order confirmation received by entrants will act as your ticket(s) for the raffle. The online order reference number or shop transaction ID if purchased in store is your raffle ticket number and will be entered multiple times where more than one ticket is purchased.

Please keep your raffle ticket receipt/online confirmation as proof of purchase.

7. Charity Aid Foundation vouchers or those funded by Give as You Earn accounts cannot be used as payment for raffle tickets.
8. In order to promote responsible gambling, a maximum of 20 chances (ticket entries) may be bought per person.
9. Raffle tickets will be entered into the draw when the whole payment is received.
10. The Grand Appeal accept no responsibility for raffle tickets which are lost, damaged, illegible or from which the prize- winner cannot be identified, or for any technical failure or event which may cause the competition to be disrupted or corrupted.
11. The closing date for entries is 11:59pm Wednesday 03rd October 2018. Late entries will be treated as a donation to The Grand Appeal.
12. The draw will take place on Friday 5<sup>th</sup> October 2018.
13. One raffle ticket entry will be drawn using a random number generator.

14. The 1st ticket number drawn will receive the raffle prize of the official Gromit Unleashed trail sculpture *Tropi-canis*. This sculpture will have been on public display throughout the trail and its condition therefore will not be as new.
15. There will be no alternatives to the prize as stated above.
16. The results of the raffle draw are final. No correspondence will be entered into.
17. The winners will be notified by e-mail/telephone no later than one week after the draw date. The winner's first name and town will be published at [www.gromitunleashed.org.uk](http://www.gromitunleashed.org.uk) and on our social media channels.
18. Where The Grand Appeal is unable to contact a prize-winner so that a prize remains unclaimed for one month following The Grand Appeal's first attempt to notify the prize-winner, The Grand Appeal may apply the prize as it sees fit, including by re-offering the prize in future raffles.
19. The prize will be released to the winner for collection on the 8<sup>th</sup> October after being included in *The Greatest Dog Show on Earth* exhibition. The winner will need to present their raffle ticket (store receipt or online confirmation) in person and provide one piece of photographic ID in order to claim their prize. If a prize is not claimed by 30<sup>th</sup> October, or sufficient proof of winnings and identity is not supplied, The Grand Appeal may apply the prize as it sees fit, including by re-offering the prize in future raffles. The winner will be responsible for collection of or delivery of the prize to its intended destination.
20. All winners are required to co-operate with The Grand Appeal's right to publish their win as and where deemed appropriate.
21. Winners may be asked to provide a photograph or to be photographed and interviewed to provide a quote about winning in order to help The Grand Appeal promote future fundraising draws, and to provide proof of age when requested.

## **22. Restrictions on the use of the prize**

(a) The winner shall not, and shall procure that any New Party shall not, do, or omit to do, or permit to be done at any time any act:

- (i) That uses the prize to further any political, quasi-political, commercial or charitable objectives;
- (ii) That associates the prize with any political, quasi-political, commercial or charitable objectives; or
- (iii)(In connection with the prize) that negatively impacts on the reputation of the charity or which damages the reputation or goodwill associated with the lot or the charity.

(b) The winner shall indemnify the charity against all liabilities, costs, expenses, damages and losses (including any direct losses, indirect losses, consequential losses, loss of profit, loss of reputation and all interest, penalties and legal and other professional costs and expenses) suffered or incurred by the charity arising out of or in connection with the use of the prize by the winner, a New Party or any third party or any breach by the winner of this clause.

## **23. Intellectual Property Rights**

(a) The winner acknowledges and agrees that no intellectual property rights in the prize will pass to the ticket Buyer as a result of winning the prize. All intellectual property rights in the prize will remain with the charity or the charity's licensors & partners.

(b) The winner acknowledges and agrees that no licences in respect of any intellectual property rights will be granted to the winner as a result of winning the prize.

(c) All goodwill associated with the prize (both at the time winning and afterwards) shall belong to the charity. The charity may at any time call on the winner to execute a confirmatory assignment of any goodwill associated with the prize and the winner shall execute it forthwith.

Where the organisers deem it appropriate and/or feasible The Grand Appeal will notify entrants of the error.
