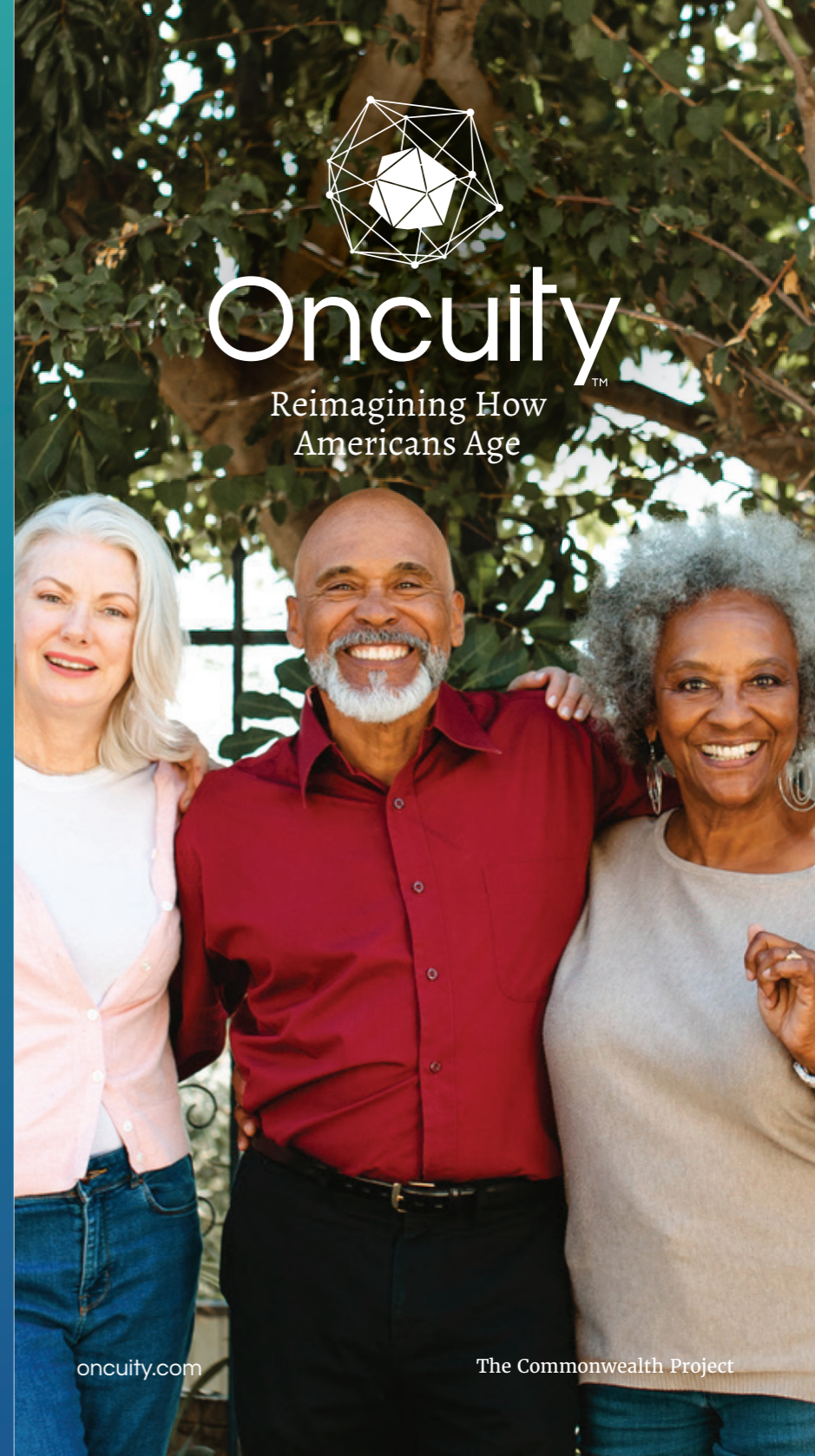

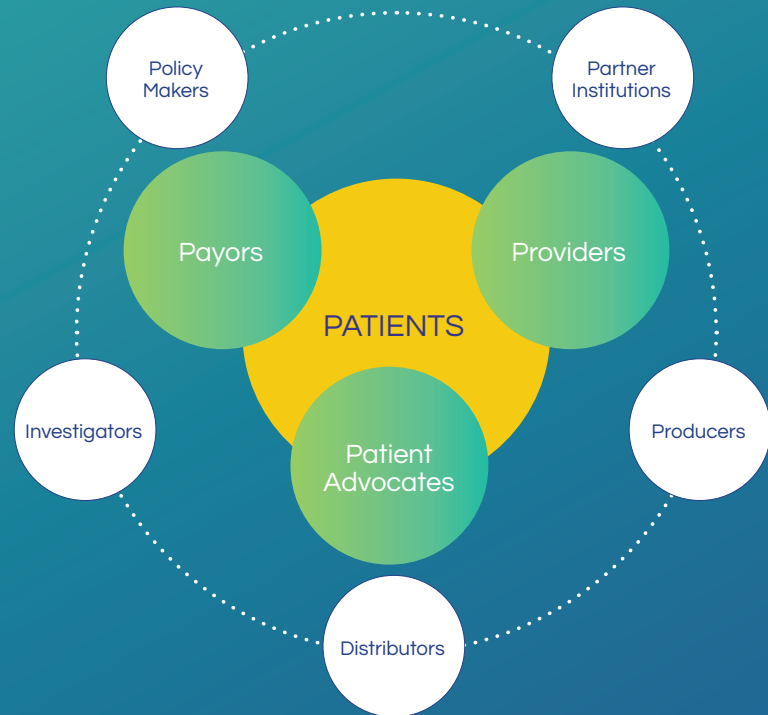

THE SITUATION

Aging Americans demand access to new forms of healthcare

Overprescribed Addictive Medications

Over **4 in 10** older adults take **5+ prescription medications** a day.

Massive Healthcare Costs

The Medicare prescription drug spend was **\$129 billion in 2016 alone** (19% of all spend).

Broken Patient Experience

The medical cannabis patient experience is **inconsistent and unregulated by healthcare**, preventing older adults from getting proper medical advice and safe access to CBTs.

Lack of Medical Oversight

Cannabis's federal status makes **healthcare professionals hesitant to encourage CBT use**, which comes at the expense of the health of older adults who end up looking for guidance elsewhere.

Limited Research To Support Policy

There is **limited health data on best practices or product usage for the unique needs of adults 65+**, which is a necessity for any type of medical, public health, and social policy.

Alternative to Pharmaceutical Medication

56% of patients ceased taking commonly prescribed pharmaceuticals (e.g. opioids) after using Oncuity.

Medicare & Payor Costs Reduced

Medicare and Medicaid combined program enrollee spending **reduces by 1.17 billion nationally** when states implement cannabis laws.
