#### MARKET SEGMENTS

### **HEMP AND MARIJUANA PRODUCTS**

This segment includes companies that manufacture cannabinoid (CBD), and related products - hemp-infused beverages, edibles, topicals, strains, among others.



#### **VAPORIZERS**

This segment includes companies that design, manufacture, sell and distribute vaping devices (vaporizers) and cartridges.

### MARKET SEGMENTS



This segment includes cannabis packaging companies, security services, insurance services, and companies that develop analyzers.



### CONSULTING

This segment includes companies offering consulting and advisory services, including cannabis testing labs.



This segment includes companies that utilize technology to improve cannabis cultivation yields and efficiencies.

### **METHODOLOGY**

Interviews with Key Market Participants: The research methodology adopted while creating this research involved conducting interviews with various key market participants enabling Verify Markets to identify various trends in the legal marijuana market.
