Description of product:

The BSD protective glove HRC 3, article no. 46503xx is made of white full chromium goatskin leather which is 0.9 – 1.0 mm thick on the palm side, and two layers of a flame retardant fabric made of cotton fibers with the surface weight of 340 g/m², in dark blue.

The palm side of gloves is made of one piece of leather, a thumb is sewed.

The cuff of gloves is made of leather on the palm side of gloves and two layers of fabric on the back side of gloves. The materials used are the same as for palm and back side, respectively.

The thumb of the back side is also made of the same leather as the palm side.

On the wrist level of the back side there is an elastic band.
