

Product description:

The BSD-Protective glove HRC 4, article no. 46504xx is made from white goatskin leather of the thickness 0.9 - 1 mm in the palm side and a cuff of palm side. The back side and the back cuff of the glove is made of two layers of dark blue denim (100% FR-Cotton) of the surface mass of 340 g/m^2 .

The gloves in palm and dorsal side have liner made of knitting fabrics (fiber: aramid).

The palm side is made of one piece of a leather, a thumb is sewed. The thumb of the back side is also made of the same leather as the palm side.
