### GENERAL INFORMATION

**EclipseUS Liquid AMS** is a 34% liquid ammonium sulfate formulation for use with pesticides when a liquid ammonium sulfate, or replacement for dry ammonium sulfate is recommended.

### DIRECTIONS FOR USE

The addition of adjuvants to some herbicides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. Before using **EclipseUS Liquid AMS**, the applicator or crops advisor must have experience with the herbicide combination, including **EclipseUS Liquid AMS**, or must have conducted a phytotoxicity test. **SHAKE WELL BEFORE USING.**

### USE RATES

Apply 1-2 quarts per acre or 1-5 gallons per 100 gallons of spray solution.

### MIXING

In the absence of specific mixing instructions found on the herbicide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed
2. **EclipseUS Liquid AMS**, dry formulations (WP, DF, WDG, SP), and dry drift retardants
3. Dry soluble and suspension fertilizers / micronutrients
4. Liquid drift retardants and flowable formulations (F & FL)
5. Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS)
6. Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
8. Liquid micronutrients and fertilizers
9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
10. Finish filling to desired spray volume level and continue agitation

### ENVIRONMENTAL HAZARDS

Do not contaminate water. Do not allow spills/wash water to enter drains, sewers or water ways.

### STORAGE AND DISPOSAL

**Protect product from freezing.** If product freezes, warm to room temperature and agitate before use. Keep containers sealed when not in use. Store in original container only.
