DIRECTIONS

Apply 2 oz (by weight) per 50 lbs of seed in the hopper box and mix in. One measuring scoop (included in case) holds approximately 2 oz. Contact Locus AG for further details.



Adequately mix Rhizolizer Prime BA with seeds to **ensure even distribution of product on seed.** Rhizolizer Prime BA can be applied with common seed fungicides. Contact Locus AG to ensure compatibility.
