# **End User License Agreement**

#### 1. Grant of License

Licensee may make copies of the Sound Libraries as reasonably necessary for backup or archival purposes only.

#### 3. Restrictions

This license is only for you. You cannot resell or give away the product, its sounds, or anything you make from them. This means you can't include them in sample packs, sound libraries, virtual instrument or any kind of sound playback device, even if you change them.

### 4. Ownership

Kompose Audio Limited retains all ownership rights in the Sound Libraries. This Agreement grants Licensee only the limited rights to use the Sound Libraries as expressly set out herein.

Kompose Audio Limited retains full ownership and copyright of all digitally recorded sounds and programs included within this product.
