Purchase Terms

A non-refundable deposit of \$800 is required to hold the puppy from the Buyer. Should the puppy have any pre-existing medical conditions as determined by a health examination given by a licensed and practicing veterinarian within seven (7) days of pickup, the Buyer is entitled to have the deposit refunded.

This puppy is being sold on limited registration; meaning no breeding rights. Full AKC registration can be obtained but must be discussed with the Breeder prior to the sale of the puppy.

Health Guarantee

Breeder guarantees the puppy to be in good health at the time of the sale to the best of their knowledge. Included in folder is the signed health certificate from our vet verifying the puppy's health.

A one year health guarantee will be warranted from the puppy's birth date. If any life threatening genetic condition develops, a signed letter from the diagnosing veterinarian is necessary, and an examination by our vet will be necessary. The puppy will be replaced or a full refund, less the deposit, given, not including any veterinarian fees or services. This guarantee is to original owner only.

We cannot control the exposure your puppy encounters after leaving our premises. Puppies sometimes get stressed when in their new home. This can be caused by the move, change of diet, too much handling, or not eating properly. This stress can bring on things that are dormant such as, but not limited to, worms, ear mites, colds, coccidia, and giardia. These conditions are treatable and do not warrant a reimbursement. We cannot guarantee that your puppy will never develop any health problems. We have done our best by having our parents health tested which means our puppies will less likely develop problems.

Pickup

Pickup is available November 21-26th. Pickup scheduled after November 26th will incur a \$50 per day fee. If more than one week passes from arranged pickup date without contact from the Buyer, the deposit may be retained by the Breeder and the Breeder has the right to cancel the sale of the puppy.

Buyer Agrees In the event that the owners cannot keep the dog/puppy, the dog/puppy in question will be returned to the breeder at no cost.

In the event that you cannot keep the dog/puppy, will be returned to the us, the breeder, at no cost. Under no circumstance will a refund will be issued. Under no circumstances will the dog/puppy be placed in a shelter, foster home, or rescued. If we, the breeder, decide to not take the dog, we can help place the dog in a new home if need be.
