1. **COMPLETE THIS CLAIM FORM.** Claims must be emailed or efaxed to the specific address for the offer.
2. **INCLUDE A COPY OF THE SALES RECEIPT.** Submit a copy of the sales receipt showing the product purchased, the serial number and the purchase date (dated between 07/01/2024 – 07/31/2024).
3. **INCLUDE A PHOTO OF THE UPC CODE.** Submit the proof of purchase by sending a photo of the UPC barcode (including serial number) from the side of the carton.
4. **SIGN THE CLAIM FORM.** This form must be signed in order to be valid.
