

LIMITED 3 YEAR WARRANTY

OUTDOOR FIRE TABLES

Modern Blaze hereby warrants this product to be free from defects in materials and/or workmanship, for the period of time and under the conditions described in each section below, subject to the limitations listed below (see *section 2*).

1. Limited Warranties

Modern Blaze warrants the concrete or metal/aluminum materials and the applied finish of this product, to be free from defects in materials and/or workmanship, for a period of three (3) years, subject to the limitations outlined below (see *section 2*).

2. Limitations

2a. The repair or replacement of parts, or the performance of service under this warranty, does not extend the life of this warranty beyond its original expiration date.

2b. This warranty is non-transferable and is offered exclusively for the benefit of the original purchaser, beginning on the original date of retail sale.

2c. Modern Blaze does not warrant this product against the following:

1. Damage occurring during transportation or installation, or damage resulting from improper installation.
2. Damage/breaking of the mounting tabs due to incorrect installation, or bending the tab multiple times.
3. Discoloration of finish or distortion of metal parts due to high heat. A wind shield is recommended to help protect your countertop from overheating.
4. Damage as a result of accident, alteration, abuse, or mis-use.
5. Scratches and damage from normal wear and tear.
6. Damages from not following the Care & Maintenance Instructions.

2d. Color finishes may vary slightly in shade and are not guaranteed to perfectly match or coordinate. Color changes and variations may occur from direct exposure to sunlight and the elements. Extreme variation in finishes may be re-finished solely at Modern Blaze option and discretion.

2e. Modern Blaze is not responsible for any additional charges that may occur during the warranty process, nor are they responsible for any travel, labor, or installation expenses.

3. Warranty Process

3a. If, during the given warranty periods, a product covered under this warranty proves to be defective in material or workmanship, a claim for warranty service should be made through your authorized Modern Blaze Dealer. Proof of purchase will be required. The authorized dealer will contact Modern Blaze to procure replacement parts and/or if additional service is deemed necessary. Modern Blaze reserves the right to choose at its option, the best method of repair or replacement, for any warranted part or product.

3b. The burners installed in the Fire Pit are excluded from this Warranty. The burners are warranted by the manufacturer. Please refer to their warranty booklet for more info.
