Crafted from toughened, tempered glass for higher strength and shatter resistance, the windscreen is equipped for outdoor performance.

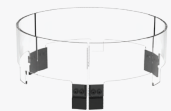

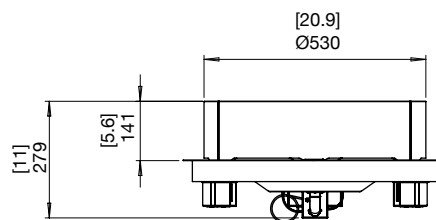

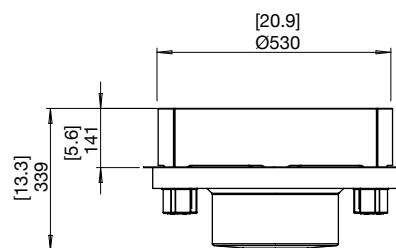

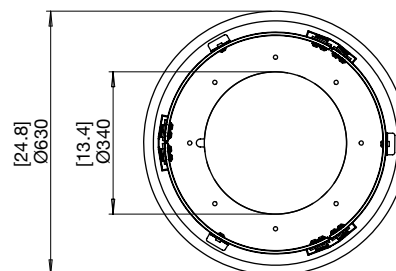
