In addition, I recognize that the exertion of playing the 'Game' could result in serious injury or death.

2) I, the undersigned, understand that the 'Game' will be ran outdoors in a forest area, and that Rocks, Trees & Branches either live or dead, Insects, and Animals that grow or inhabit the forested area pose a risk of serious injury or death and accept any and all risk if encountering any of the aforementioned. "The Farm Airsoft" does not store or supply any advanced medical equipment or devices. Players with severe allergies or medical conditions are responsible for ensuring they possess appropriate medical equipment.

3) I hereby certify that the equipment used is certified as ballistic and/or at the very least Paintball/Airsoft specific for the use of, but not limited to, eye protection. I understand full face protection is required for all players under the age of 18 and recommended as the minimum safety protection for all players over the age of 18 and I understand sole responsibility to sure this on myself, the player.

4) Despite these and other risks, and fully understanding such risks, I wish to play the 'Game' and hereby assume the risks of playing the 'Game'. I also hereby hold harmless 2076415 Ontario Inc. (aka 'The Farm Airsoft'), 1353833 Ontario Inc. (aka 'Airosft Assault'), 'KGC Farms' and any 'Sponsors', 'Landlords', Organizers and the properties thereof, and indemnity them against any of all claims, actions, suits, procedures, costs, expenses, including, legal fees and expenses, damage and liabilities arising out of, connected with or resulting from my playing of the 'Game', including equipment.
