In animals, irrespective of the route of administration, the observed symptoms are caused by an action at the level of the central nervous system with sleepiness until unconsciousness, ataxia and convulsions. You can have the death by respiratory failure. The relatively rapid percutaneous penetration and high, in particular compared to other organic solvents. The skin after contact, becomes four times more permeable to other substances.

In humans, the exposure to the substance at doses equal to or greater than 100 ppm, carried out on volunteers, causes irritation of the mucous membranes of the nasal and ocular, oral Airways. In a person exposed to gradually increasing concentrations, from 1 to 2 ppm in 2050 hours, we noticed the presence of a major tear hypersecretion with

Blepharospasm and nasal congestion oropharyngeal and accompanied by pain. After 15 minutes of exposure hanging nasal and oropharyngeal pain subside; After an hour the irritation and nasal congestion lasts for 24 hours. Clinical and biological examinations carried out on those exposed have not revealed any abnormality.

Other effects (e.g. with a narcotic effect); Not available.

Other: metabolism, kinetics, mechanism of action, etc.;

It is absorbed via the respiratory, digestive and skin. The complete solubilit in water and then the high coefficient of blood/air Division promotes its penetration due to respiratory failure. Blood rates are not proportional to the exposure. The substance is concentrated mainly in the liver where it causes an increase in organ weight and an increase in microsomal enzyme activities.

The metabolism of ether propylene glycol monomethyl ethers mainly hepatic.

The main potential routes of exposure are inhalation and skin contact. Percutaneous absorption rapid and important. Not been shown any power-sensitizing of the substance.

In animals the most observed effects include central nervous system depression, weight gain of the liver and kidneys, decreased body weight and increased urinary pH. The narcosis appears in the first few weeks of intoxication and then disappears. In the literature are not reported long-term effects in humans. Has degreasing power liquid skin.

All tests are performed in vitro negative results. Are not described in vivo test.

The substance has no effect on testicular activity and has only a weak potential for alteration in fetal development.


