This warranty means that the "MAIN ENGINE ASSEMBLY" (namely block and head casting and all related moving parts.

Warranty is on motor only and not on external parts, eg alternator, starter, turbo, clutch, water pump, radiator, water hoses, fuel pump components relating to tune, eg distributor, electronic ignition, fuel injection, carburetor, oil seals, diesel engines-injector pump and injectors & seals.

The warranty excludes any consequential damage and/or any consequential damage caused by a non-covered part.

CONDITIONS OF WARRANTIES

THE UNIT MUST BE FITTED BY AN AUTOMOTIVE TECHNICIAN AND USED IN THE APPLICATION INTENDED BY THE ORIGINAL MANUFACTURER, AND MUST NOT BE ALTERED OR MODIFIED IN ANY WAY

IN THE EVENT OF A CLAIM:

- 1. Toycomm must be contacted before any work is carried out.
- 2. Toycomm will not be liable for the costs of any work carried out, without prior approval.
- 3. Toycomm reserves the right to decide in the event the part should fail, whether it be returned to them for repair, replace the part supplied, or make a cash contribution toward repair of same, or refund on return.
- 4. The term of this warranty is for (Please refer to your invoice, for duration terms) whichever occurs first and providing Toycomm is satisfied that all warranty conditions have been adhered to. If Toycomm decide that if the parts failure is the result of negligence this warranty becomes void.
- 5. PARTS ONLY supplied. Labour charges can be paid up to \$65 p/h ex GST, in an event of labour works required for warranty only.
- 6 Any claim working out to more than the original purchase price will not be considered.
- 7. The maximum claim under the warranty is deemed to be the purchase price of the unit, GST inclusive
- 8. Should the supplied unit be used with any custom modifications, warranty will be void.
- 9. All works to be carried out by a qualified Mechanic.

TO VALIDATE THE ENGINE WARRANTY THE FOLLOWING MUST BE CARRIED OUT:

- 1. Check or replace cambelt / water pump / thermostat / Seals (as there is no Warranty on these parts). You the customer or workshop, needs to be confident and satisfied, with these parts prior to installation of the engine.
- 2. Check all frost plugs and replace if necessary.
- 3. All radiator and heater hoses must be checked and replaced if doubtful, and Radiator must be thoroughly flushed and flow tested. If radiator is faulty, it must be replaced.
- 4. Ensure cooling system is correctly bled.
- 5. Where injectors are not supplied with the engine, it is strongly recommended to install new injectors, as damage caused to the engine assembly due to worn injectors (e.g damaged pistons, cracked cylinder heads ect) will void any warranty.
- 6. Heat tabs have been fitted. If removed or melted, warranty will be void
