Burn Pits 360 was founded in 2009, in honor of Army Captain Le Roy Torres, who served in the U.S. Army for 23 years (7 years – Active, 16 Years – Reserve). He deployed to Balad, Iraq from 2007-2008. Captain Torres also served the State of Texas as a State Trooper for 14 years. Torres suffers from complications from illnesses that began after he was exposed to toxic fumes during service in post-9/11 Iraq. Le Roy was subsequently diagnosed with Constrictive Bronchiolitis and Toxic Brain Injury. After experiencing delay, denial of benefits, and ineffective treatment from his physicians, Le Roy alongside his wife, Rosie, founded Burn Pits 360.

#### BURNPITS 360 veterans organization



Burn Pits 360 is a 501(c)(3) non-profit, for-impact Veterans organization located in Robstown, Texas. Our mission is to educate, equip, and empower individuals by networking with those affected by combat related illnesses. Our programs allow us to set the pathway to justice through advocacy, outreach, education, and research.

The Warrior Support Center is our headquarters and a one-stop facility where Warriors andtheir families access information on deployment related illnesses, support services, resources, and training tailored to their individual needs. It is equipped with a care station, career closet, computer lab, recreation room, education room and case management room.

Equipping our warriors and their families for a successful transition into society bridges the gap between the unmet needs and the consequences felt by those battling the effects of military deployment and war. Our warriors face barriers in accessing healthcare and benefits, resulting in cases of homelessness, poverty, and suicide. Our Warrior Hope Network Program is one of many programs we offer that allows us to deliver access to various healthcare modalities such as Oxygen concentrators, hyperbaric oxygen chambers, stem cell therapy, infrared sauna detoxification, and more. The network also includes additional resources such as scholarships for veterans to access care.

On October 21st, 2023, we are hosting our 5th Annual 20-mile ruck march. This year our efforts will go towards Burn Pits 360 Veterans Organization and a very special Soldier Honoree who is suffering from the effects of Toxic Exposure and/or Breast Cancer. Togetherness creates impact & it is *together* that we are made strong. Your sponsorship or donation towards this event will not only help us to "carry the load" for those affected, but to also raise awareness towards medical screenings, treatment, and health and compensation options . ## ANNUAL TEXAS PATRIOT RUCK MARCH

The Annual Texas Patriot Ruck March is a yearly fundraising event hosted by Burn Pits 360 in efforts to raise funds for the organization and special honoree. The Texas Patriot Ruck March creates awareness while promoting networks to assist in the enhancement of evolving methods in connecting with our nation's heroes. Each honoree selected by the organization has experienced or is currently experiencing a medically related financial burden. Through the efforts of national and local supporters, such as yourself, Burn Pits 360 presents a portion of the proceeds raised to selected honoree. Proceeds raised go directly towards the relief of medical costs, daily living necessities and our organization in continuing the efforts of Advocacy, Education, and Empowerment.

Each year, numerous supporters gather and ruck alongside one another for 20 miles as they spread pure heart and camaraderie throughout. Marchers are briefed and prepped in safety measures and provided with a Gear Pack, event shirt and a meal concluding the ruck. Along the route, there are stations set for rest/wellness checks/hydration. Fall back vehicles are also provided for those marchers who are unable to make the entirety of the march.

It is through sponsorships and donations that this event is at all possible. Not only will your support assist in our mission, but it also will help provide our marching advocates with fresh water, energizing snacks, and a hot meal as they relentlessly and wholeheartedly walk for a cure.



#### Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

Form 1099-INT (interest earned or paid)

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)
- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T-(tuition)
- Form 1099-C (canceled debt)

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See What is backup withholding, later.
