## IS IT TIME TO LICENSE DENTURISM IN ALL 50 STATES?

A telling example happened to me fifteen years ago, when I hired a new prosthodontist with the assurance he knew everything there was to know about dentures. But when he did his first denture, I was shocked to find out that in all his training he had never seen or heard of Gothic Arch Tracing. After I showed him, he was shocked as well!



New dentures from a properly trained and experienced professional is a minimally invasive and affordable solution. New advances in denture technology (scanning, digital, and more) have the potential to make dentures better than ever. But denture-wearers in the states without Denturists are reluctant to go to the dentist for new dentures, and maybe for good reasons. It was probably a dentist who removed their teeth in the first place! Without easy and affordable access to quality denture care, these people continue to live in quiet toothless misery, with dirty old dentures that no longer fit, suffering from long-term chronic infections and sore spots that just become a part of everyday life.

The edentulous population is already huge and growing even bigger. We need more health professionals to maintain the health and quality of life of denture-wearers.
