To ensure that those remain below trace levels, the upper concentration levels have not been increased (compared its last publication in the Amendment 43 (2008)). In the presence of Treemoss extracts, the level of Oakmoss in the respective category has to be reduced accordingly, such that the total amount of both extracts does not exceed the maximum permitted level in each category as listed in the table above. If the same fragrance mixture is intended to be used in more than one IFRA Category, then the most restrictive limitation (based on foreseen use concentrations and maximum permitted level) will apply. Specification: Oakmoss extracts must not contain added Treemoss, which is a source of resin acids. Traces of resin acids may be carried over to commercial qualities of Oakmoss in the manufacturing process. These traces must not exceed 0.1% (1000 ppm) of Dehydroabietic acid (DHA) in the extract.
