4. FIRST-AID MEASURES

4.1. Description of necessary first aid measures

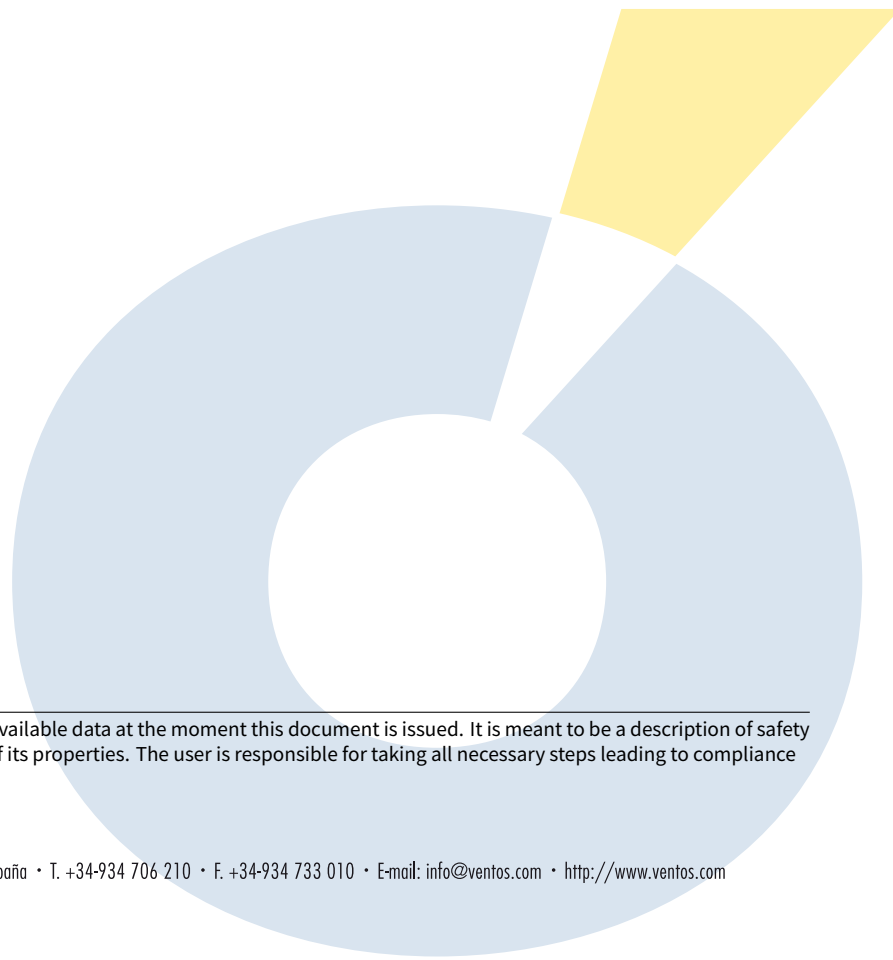
