#### 6. ACCIDENTAL RELEASE MEASURES

### 7. HANDLING AND STORAGE

#### Handling

Respiratory protection

Number 2004-110].

In August 2004, the United States Flavor and Extract Manufacturers Association (FEMA) issued a report entitled "Respiratory Safety in

the Flavor Manufacturing Workplace".

Both of these reports provide recommendations for reducing employee exposure and for medical surveillance in the workplace. The recommendations in these reports are generally applicable to the use of any chemical in the workplace and you are strongly urged to
