Report from President (Rob Harper)

- Booster club member roles were discussed (first points of contact). For example-website/social media begins with MJ with the exception being ecommerce which would go to Misty then Bill/Rob.
- The idea of an end of year "lessons learned" was discussed-website, Shopify (each role having their own acct), Square vs Shopify

Faculty Liaison Report (Rick Lafavers)

- Girls basketball playoffs will be on 2/13, boys as well.
- Swim finished regionals.
- Soccer is in the second half of season.
- Softball/baseball starting games.
- As of now, no volleyball coach has been hired.
- The volleyball fundraiser was discussed. Wade Smith would be in charge, he has brainstormed with Rick about ideas. No dinner this year, would continue with reading with Panthers at Title 1 school. There would be the Hall of Fame induction, stars vs legends game and 2 youth camps. Camp registrations have to go through RevTrak, if board is handling funds, all has to be done properly.

Treasurer's Report (Tina Worrell/Misty Provazek)

- The January 2024 financial report summary and full financial documents were sent out via email prior to the meeting to all board members and a paper copy was given to all in attendance.
- There are 2 sponsors who have not paid. ServPro is not responding to any forms of communication.

VP Booster Club Report (Bill Stratton)

- Estimates have been received from Hawkeye and Cap Loop in regards to repairs to baseball and football concession stands and were given to those in attendance.
- Recommendations of items that are most critical: a. baseball concession stand foundation (priority) b. gutters for both c. construction of overhang for both d. replace door frames.
- Cap Loop/Leon Foundation estimate for baseball foundation is \$5500 (1-2 day repair)-they will raise the corners of foundation.

- MOTION #3: A motion was made to approve Cap Loop/Leon Foundation to do the work on the baseball concession stand foundation: Bill Stratton, Mercedes Farr 8 in favor, 0 opposed, 0 abstains, motion carries
- We also need to replace locks on all doors, the locks match for both concession stands and get spare keys.
- Further discussion included the approval needed from district to get repairs completed. The suggestion was made to start with Mr. Brogan.

VP of Athletics Report (Kendra Gammons, Allyson Morris)

- With the exception of football, TSRs don't have access to parent emails and are only able to post on Sports You.
- Rick can send a message to all sports using Rank One.
- They have heard back from girls softball about a purple out game and girls soccer, who would like to do the 1st playoff game.

Director of Events Report (Trang Revere-Lisa Tagliarino update on fundraiser)

- Sponsorships for soiree are over \$20,000. Table sales are going better than individual ticket sales.
- On the expenses side things are coming in under numbers.
- Spirit nights to help raise money for booster club will be held at the following restaurants: 2/19 Texas Biergarten, 2/27 Brandanis, 3/4 MOD Pizza, 3/11 Stomps, 3/22 Olivers A flyer will be made for these nights that can be shared on social media.
- Invitations will be sent to Purple Jackets, coaches, Mr. Brogan.
- 11x17 posters will be going out in local businesses. There will also be flyers madecan they go out at spring games? Concession stands?
- Lisa will get an email ready for Rick to send out in Rank One.
- Communication was made to Royals, band, ROTC about coming to the soiree. There will be a \$500 donation made to their organizations that could go up to \$1000.
- Drumline and ROTC can be at entrance to soiree.

Director of Membership Report (Natalie Frederick)

- The booster club is currently at 125 members, \$11,000 has come in this year.
- There have been 20-25 new members in the last few weeks.
- Those that sign up at the soiree and spring football game can rollover their membership. Otherwise, membership is Aug 1-June 1.
- All board members should have paid for a membership.

Director of Sales Report (Mercedes Farr)

- Concession stand sales are going great.
- There was conversation about making a director of concessions position. The current sales position covers concessions and sponsorships, could we create a specific concessions board position that is able to vote?
- The March agenda will include discussing splitting the positions.
