### **Report from President (Rob Harper)**

- The TSR videos have been started, financials are the first section. A power point will be put on the booster club website. Each video will be about 1 minute, 30 seconds.
- Basketball-we would like to start doing halftime activities during home basketball games (ex-shoot off during halftime for prizes, cheerleaders can throw shirts). There is a budget line in financials for gift cards.
- Upcoming home games: 11/14 (boys), 12/5 George Ranch, 11/20 (girls) Hightower, 1/13/24 (boys) Hightower, 1/26 (boys) Clements.
- The board should be receiving fundraiser information. Approval procedure-Mercedes and Bill should be receiving notifications.
- A question was raised about getting wish list items earlier in the year to help get sponsorships for fundraising.

## Faculty Liaison Report (Rick Lafavers-Rob speaking)

- Scoreboard update-FBISD athletic director will not do any repairs unless we front half of the \$7,000 bill. Rick will split between football budget and booster budget (\$3500). Reasoning is that we get revenue from the signage on scoreboard we should be paying. Not sure on start date for the work.
- There is a 10 year warranty on quote.

- The October 2023 financial report summary and full financial documents were sent out via email prior to the meeting to all board members and a paper copy was given to all in attendance.
- There is one unpaid sponsorship-Fort Bend Dental.
- There was discussion about budget change proposals (changes include increases in fees, corporate financials, fundraising events).

- The spring fundraiser chair is Lisa Tagliarino. Looking at March 23 for possible date due to venue issues. They are trying to schedule a meeting to get committees/volunteers. The event will likely be held at Constellation Field, working on a fee with Aramark. Lisa has a call on Wednesday with catering manager. Spring fundraiser will be a casino theme, looking to get auction items donated, there will be a big push on sponsorships. Ticket price will be in the \$75 range.

Director of Membership Report (Natalie Frederick-info shared prior to meeting)

- Updates-clear bags/hats for \$200 level are on order, should be here this week.
- More member shirts have been ordered.
- Senior signs are on sale!
