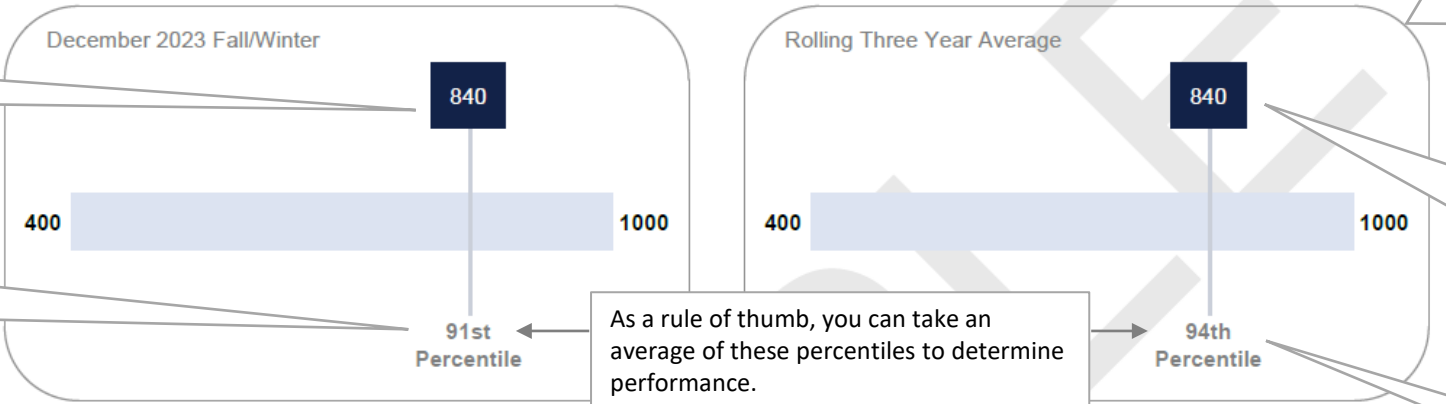

Rolling – only the most recent 3 years of data will be included.

Individual score is in the dark blue box, this is based on a scale of 400-1000, in 10-point increments.

Percentile– Your percentile ranking based on test takers to date.

Actual is the best estimate of the means and medians.

95% Confidence Interval – you can be 95% confident that the estimate falls within this range.
