

## NOTICE OF RENEWAL OF LICENCE

To:

### **Pask Winery Limited**

Licence Number 29/OFF/038/24 replaces Licence 29/OFF/033/21.

The off-licence in respect of the premises situated at 1133 Omahu Road, Hastings and known as "Pask Winery" is renewed.

The present conditions of the licence shall continue to apply subject to the following changes:

#### Operating hours

The operating hours have changed from:

Monday to Friday 11.00 am to 4.00 pm. Saturday and Sunday 12.00 pm to 4.00 pm.

To:

Monday to Sunday 10.00 am to 5.00 pm.

### Licensed area

The licensed area has changed and is described in the plan date stamped as received by the Hastings District Licensing Committee, on 7 December 2023.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, the licence continues in force:

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.

The period for which the licence is renewed is three years and nil months, expiring on:

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), Pask Winery Limited (the licensee) is authorised to sell alcohol on the premises situated at 1133 Omahu Road, Hastings and known as "Pask Winery", to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

### **CONDITIONS**

This licence is subject to the following conditions:

- Alcohol may be sold only on the following days and during the following hours: Monday to Sunday 10.00 am to 5.00 pm.
- No alcohol is to be sold or delivered on Good Friday, Christmas Day, or before 1 pm on Anzac Day. b.
- No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine or fruit or c. vegetable wine made:
  - on the premises; or
  - from grapes or fruit harvested from land on which the premises are situated.
- The holder of this licence must take reasonable steps to verify that the buyer of any alcohol that the d. holder sells by remote sale and, if a person other than the buyer is to receive it, to verify that the receiver) is not under the purchase age.
- The holder of this licence must display on the website, in a prominent place, the alcohol licence number, e. expiry date and a copy of the licence for the premises.
- The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to f. prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- Drinking water is to be freely available and free of charge to customers at the following area where free g. alcohol samples are being supplied: In each area where free alcohol samples are provided.
- h. The licensed area is described in a plan date stamped as received by the Hastings District Licensing Committee on 7 December 2023.

#### **Duration**

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force:

- either:
  - until the close of the period for which it was last renewed: or
  - if it has never been renewed, until the close of the period of 12 months after the day it was issued: but (ii)
- b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either:
  - until the close of the period of 3 years after the period for which it was last renewed; or (i)
  - if it has never been renewed, until the close of the period of 4 years after the day it was issued.
