

HIDE-DRANT SERIES STANDARD STAINLESS STEEL

SPECIFICATION:

- Sanitary Yard Hydrant- approved in Illinois, Indiana, Michigan, Ohio and Wisconsin- the most restrictive states in the United States.
- Frost proof- when used correctly, simply turn standpipe counter-clockwise three turns to disconnect the 3/4" NPT inlet from the bottom case stainless steel stop valve and remove, then drain standpipe for freezing temperatures. No tools required to remove and reinstall standpipe.
- Stop valve at the bottom of the Hide-Drant is automatically opened when the standpipe is reinstalled. Seals between the stainless-steel stop valve and standpipe holds water before the valve is reopened.
- 3/4" No lead brass vacuum breaker outlet can be in any direction. By simply pivoting outlet counterclockwise to direction desired, approximately three revolutions needed to remove standpipe. Do NOT overtighten standpipe by forcing clockwise revolution of outlet.
- 1 1/2" schedule 40 Bottom case has one way flapper drain to remove any spilled water in case, in addition to a cover over drain on outside of the case protects drain from backfill.
- With removable riser pipe the bottom case can be capped off, allowing the grass to be mowed right over the top and it also improves appearance of landscape.
- ASSE approved vacuum breaker and outlet valve included.




