I hereby authorize the City of Rock Hill Police Department (the Police Department) and all of the Police Department's sworn officers (the Officers) to act as my agents in ordering any individual(s) present upon the Premises (as defined below) without authorization, permission, or other legal justification (Trespassers) to leave the Premises and to not return until such a time as the Premises' owner, manager, or other lawful authority so authorizes.

I understand that the Officers of the Police Department may order Trespassers to leave the Premises in their discretion, and that if the Trespassers do not leave, the Officers may arrest the Trespassers, when appropriate, for violation of any applicable trespass statutes and/or ordinances, including S.C. Code Ann § 16-11-620.

I further understand that I have authorized the Officers of the Police Department to order the Trespassers to remove from the Premises any vehicle(s) which the Officers have reason to believe are under the control of the Trespassers (Vehicles); to make such arrangements as the Officers deem necessary and appropriate to have the Vehicles removed from the Premises in accordance with the City of Rock Hill Code of Ordinances, Article III, Section 30-151 et seq., if the Trespassers refuse to remove the Vehicles upon such request from the Officers or upon the request of the Premises' owner, manager, or other lawful authority. Provided, however, that in no event shall any Officer make any arrangements to have any vehicles removed from the Premises unless there is posted in a conspicuous place on the borders of the Premises near each entrance a notice stating that unauthorized vehicles are subject to being towed at the owners' expense, in compliance with S.C. Code Ann § 16-11-760.

I agree to testify in court that I have authorized the Police Department and the Officers of the Police Department to identify Trespassers on the Premises; to notify the Trespassers to leave the Premises and not to return pursuant to the terms of this Agreement; to arrest the Trespassers if the Trespassers refuse to leave the Premises upon the request of an Officer, or if the Trespassers return to the Premises at a later date without being duly authorized as set forth above; and to remove unauthorized vehicles from the Premises, in accordance with the terms and conditions set forth above.

I further agree to notify by way of certified letter those Trespassers who have been so identified by the Police Department, as well as any individuals identified as Trespassers by myself, other property owners, managers or authorized agents that their presence on the Premises is prohibited pending authorization as set forth above and applicable state and local law.

I agree to indemnify and hold harmless the Police Department and its Officers of and from any legal claim(s) arising out of the Officer's actions in accordance with the terms and conditions of this Agreement and state and local law.

This Agreement shall continue in full force and effect from the date set forth below until either I or the Police Department terminates this Agreement in writing at any time, without cause or notice.
