SECTION 4. FIRST AID MEASURES

4.2 GENERAL ADVICE:

SECTION 7. HANDLING AND STORAGE

7.1 PRECAUTIONS FOR SAFE HANDLING: Isolate from oxidizers, heat, & open flame. Use only with adequate ventilation. Avoid or repeated breathing of vapor or spray mist.
