4. First-aid measures

5. Fire-fighting measures

6. Accidental release measures

Methods and materials for containment and cleaning up

Prevent product from entering drains. Cover with plastic sheet to prevent spreading. Absorb in vermiculite, dry sand or earth and place into containers. 7. Handling and storage

Precautions for safe handling
