#### BOROUGH OF HASBROUCK HEIGHTS COUNTY OF BERGEN, NJ ORDINANCE NO.2508

AN ORDINANCE TO ADD TO CHAPTER 190 ENTITLED "PARKING LOTS" CODE OF THE BOROUGH OF HASBROUK HEIGHTS AND TO SUPPLEMENT THE SAME WITH ARTICLE IV WHICH SHALL BE ENTITLED "PUBLIC PARKING PERMITS AND DAYTIME PARKING AT THE WALTER AVENUE MUNICIPAL PARKING LOT"

BE IT ORDAINED by the Mayor and Council of the Borough of Hasbrouck Heights, in the County of Bergen, New Jersey, that Chapter 190 entitled "Parking Lots" of the Code of the Borough of Hasbrouck Heights be and is hereby amended so that Article IV be added and read as follows:

### Section 190-15 Daytime Parking Rules for The Walter Avenue Municipal Parking Lot.

Parking shall be permitted for four (4) hour periods only during the hours of 8:00 a.m. and 10:00 p.m. Borough of Hasbrouck Heights official vehicles shall be exempt from this section while being used for official Borough Business.

# Section 190-16 Special Event/Emergency All Day Parking Flat Fee

Notwithstanding any provision set out in this Section or in any other Ordinance of the Borough, the Borough Administrator may in his/her discretion from time to time suspend the regulations set out herein and impose a per diem flat fee parking fee not to exceed \$25.00/day per vehicle.

# Section 190-17 Overnight Parking Rules for The Walter Avenue Municipal Parking Lot.

All of the parking spots shall in The Walter Avenue Municipal Parking Lot shall distributed to residents of the Borough of Hasbrouck Heights for their enjoyment and allow for overnight parking within the confines of the regulations set below:

- A. Eligibility for Overnight Parking Spots Rental.
- (1) Only residents of the Borough of Hasbrouck Heights may apply for rental of the aforementioned Overnight Parking Spots; and
- (2) All vehicles must be registered to an address located in the Borough of Hasbrouck Heights; and
- (3) No commercial vehicles shall be eligible.

#### B. Application and Permit Procedure.

Applications shall be accepted on a "first in time basis" annually.

- (1) Upon submission of applications a fee set out in the Borough's Fee Ordinance §133-21.2 (Parking Lots) shall be due.
- (2) Permits shall be granted on a "first in time basis" annually.
- (3) Application forms shall be available through and submitted to the Borough Clerk
- (4) Permission in any one (1) year period shall not give the same party priority in

Proceeding years.

- C. Rules and Regulations.
- (1) Overnight parking shall be between the hours of 8:00 p.m. and 8:00 a.m.
- (2) No commercial vehicles shall be allowed to park overnight.
- (3) Overnight parking shall be allowed by permit pursuant to this section only.
- (4) The Borough of Hasbrouck Heights reserves the right to suspend this section at the discretion of the Borough Administrator.

Section 190-18. Violations and penalties.

Article IV shall be subject to the same penalties as contained in Section 190-11. In addition to the aforementioned, any vehicle found to be in violation of this Article by any member of the Borough of Hasbrouck Heights Police Department shall be subject to towing and impoundment of same at the owner's expense.

This Ordinance shall take effect immediately after publication thereof and final passage as required by law. If any section, subsection, paragraph, sentence, clause or word of this Ordinance shall be adjudged invalid by a Court of competent jurisdiction, such invalidity shall not affect the validity of the remaining portions of this Ordinance it being intended that all such portions be severable in such event.

AN ORDINANCE TO ADD TO CHAPTER 133 ENTITLED "FEES" CODE OF THE BOROUGH OF HASBROUK HEIGHTS AND TO SUPPLEMENT §133-21.2 (FEES UNDER CHAPTER 190, PARKING LOTS WITH SUBSECTION B. PROVIDING FEES FOR PARKING AT THE WALTER AVENUE MUNICIPAL PARKING LOT

BE IT ORDAINED by the Mayor and Council of the Borough of Hasbrouck Heights, in the County of Bergen, New Jersey, that Chapter 133 entitled "Fees" of the Code of the Borough of Hasbrouck Heights be and is hereby amended so that §133-21.2 (Fees Under Chapter 190, Parking Lots) is amended to add subsection B and read as follows:

B. Public Parking at the Walter Avenue Municipal Parking Lot shall be at a rate of \$0.25 per quarter hour; overnight annual parking permit shall be \$600.

If any section, subsection, paragraph, sentence, clause or word of this Ordinance shall be adjudged invalid by a Court of competent jurisdiction, such invalidity shall not effect the validity of the remaining portions of this Ordinance it being intended that all such portions be severable in such event.

#### BOROUGH OF HASBROUCK HEIGHTS COUNTY OF BERGEN, NJ ORDINANCE NO. 2510

CAPITAL ORDINANCE TO APPROPRIATE THE SUM OF \$176,000 FOR THE RESURFACING OF BALDWIN AVENUE (FROM BOULEVARD TO THE LODI BORDER) IN, BY AND FOR THE BOROUGH OF HASBROUCK HEIGHTS, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY, AND PROVIDING THAT SUCH SUM SO APPROPRIATED SHALL BE RAISED FROM A FEDERAL GRANT AND FROM CAPITAL FUND BALANCE AND THE CAPITAL IMPROVEMENT FUND OF THE BOROUGH.

BE IT ORDAINED by the Borough Council of the Borough of Hasbrouck Heights, in the County of Bergen, New Jersey, as follows:

Section 1. The Borough of Hasbrouck Heights, in the County of Bergen, New Jersey (the "Borough") is hereby authorized to resurface Baldwin Avenue (from Boulevard to the Lodi border) in, by and for the Borough. Said improvement shall include all work, materials and appurtenances necessary and suitable therefor.

Section 2. The sum of \$176,000 is hereby appropriated to the payment of the cost of the improvement authorized and described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be raised from a Federal grant and from Capital Fund Balance and the Capital Improvement Fund of the Borough, as hereinafter provided. The sum of \$146,050 received or to be received as a grant from the Bergen County Community Development program, pursuant to the Federal Housing and Community Development Act, is hereby appropriated to the payment of the cost of said purpose. The sum of \$21,150 is hereby appropriated from Capital Fund Balance of the Borough to the payment of the cost of said purpose. The sum of \$8,800 is hereby appropriated from the Capital Improvement Fund of the Borough to the payment of the cost of said purpose.

Section 3. Said improvement is a lawful capital improvement of the Borough having a period of usefulness of at least five (5) years. Said improvement shall be made as a general improvement, no part of the cost of which shall be assessed against property specially benefited.

Section 4. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent

of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.

Section 5. This ordinance shall take effect at the time and in the manner provided by law.
