#### INSTALLATION INSTRUCTIONS

- a) Raise vehicle allowing the axle to hang freely.
- b) Remove existing bump stop assembly.
- Assemble Aeon rubber spring and bracket as shown in the adjacent diagram.
- d) Mount Timbren assembly using OEM fasteners.
- e) Lower vehicle.

#### NOTES:

There are left and right brackets in each kit.

When removing OEM fasteners, use penetrating fluid.


- a) Levante el vehículo dejando que los ejes cuelguen libremente.
