Donation Period: May 2019-Ongoing

Details of Partnership

By entering into this Agreement Partner expresses its commitment to plant trees and change lives by contributing funds to the Company in the manner set forth below.

Terms and Conditions of Partnership

Partner agrees to donate to the Company on a(n) quarterly basis, an amount that will be determined by the Partner, with the purpose of funding the Company’s Forest Garden projects. ***Partner will notify the Company of the actual amount to be donated*** and the Company will then generate a pledge invoice for that amount, establishing the total number of trees to be donated calculated at no less than \$0.10 US per tree. 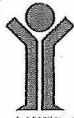



