Position Summary

Applies knowledge of electrical/electronic and mechanical principles in determining equipment malfunctions and applies skills in restoring equipment to operation. Provides skilled mechanical and electrical/electronic support to support the achievement of the site's business goals and objectives.

Essential Tasks and Responsibilities

- Performs highly diversified duties to install and maintain production machines and the plant's facility's equipment.
- Plan, layout, install and repair a wide variety of complex electrical equipment including automatic machine and process controls, control centers and panels, relays, circuit breakers, electronic controls, and other equipment involving PLC, Computer interfaces, etc.
- Installs, starts up and shuts down equipment in accordance with Company safety procedures for machines activation and shutdown and in compliance with OSHA requirements.
- Advises operators and line mechanics of operation procedures and requirements for working safely with electrical/electronic and mechanical equipment and controls.
- Provide emergency/unscheduled repairs of production equipment during production and performs scheduled maintenance repairs of production equipment during machine service periods.
- Diagnose problems, replace or repair parts, detect and replace defective control modules, test and make adjustments.
- Perform regular preventive maintenance on machines and plant facilities including lighting systems, generators, etc.
- Read and interpret equipment manuals and work orders to perform required maintenance and service.
- Perform regular preventative maintenance on machines, equipment, and plant facilities.
- Use a variety of hand and power tools, electric meters, and material handling equipment in performance duties.
- Detect faulty operations, defective material, and report those and any unusual situations to manager.
- Comply with safety regulations (OSHA and Company) and maintain clean and orderly work areas.
- Perform all other duties as assigned or needed.
