## **UPDATE ON ASX SUSPENSION**

Wide Open Agriculture Limited (ASX: WOA) ("WOA" or the "Company") wishes to provide an update on our current standing regarding our ongoing suspension from the Australian Securities Exchange (ASX). We understand that this is a significant issue for our stakeholders and assure you that we are moving as swiftly as possible towards regaining compliance. Our efforts to achieve this have been balanced with our determination not to compromise our commercial opportunities.

As announced on 24 April 2023, we previously anticipated that we would be able to announce our commercial Buntine Protein® production partner by June 30, 2023. Despite missing this timeline due to factors outside the Company's control, we want to reassure shareholders that we are working diligently to finalise all necessary agreements and expect an official announcement will be made in the coming weeks.

From a commercial perspective, we are maintaining a steady pace. Although the timeline for this announcement has shifted slightly, our business strategy and operations remain on track. Further updates will be provided as soon as more information becomes available and we look forward to sharing more positive news in the near future.

CEO Jay Albany said; "We are extremely proud of our team for their steadfast dedication and commitment to achieving our strategic objectives, in spite of these challenges. Our team is fully engaged and working assiduously to navigate these circumstances. We want to express our sincere gratitude to our shareholders for their ongoing patience and trust in our management. We appreciate your continued support as we work towards resolving this situation and advancing our commercial objectives."
