

## Harvest Chili Cook-Off Festival | Saturday, October 28th CHILI COOK-OFF RULES OF PARTICIPATION

- 1. Set up will begin at 10am. You will have 3 hours to set up your spot and make your chili hot and ready to serve.
- 2. All chili must be kept hot at a temperature of 165 degrees or more from 1pm until 3pm.
- 3. Samples of your chili must be served in between 1pm and 3pm.
- 4. Judging of the winning chili will be at 3pm.
- 5. You must cook a minimum of 3 gallons of chili. (2 ½ gallons for samples and a ½ gallon for judging).
- 6. Everyone involved with preparation and serving of your chili must wear food service gloves.
- 7. Your napkins, sample cups, spoons, and judging soup bowls will be provided by the Cider Press.
- 8. Your vending area is a 10x10 space. You are responsible for a 10x10 canopy, tables, chairs, cooking equipment and anything else you may need.
- 9. There will be NO electricity available. All cooking equipment must be gas or propane (camp stove, grill, portable propane stove).
- 10. You must provide your own water and soap for hand washing. (NO water will be available on site).
- 11. You are responsible for the cleaning of your site and must provide your own trash bags.
- 12. All vehicles must be removed immediately after set up.
- 13. Entry fee is \$20.
- 14. A \$40 returned check fee will be assessed for vendor application payment checks returned for insufficient funds.
- 15. Taylor's Farm Market, LLC dba Cider Press Deli & Grill assumes no responsibility for any loss, damage, injury, or claim arising out of the participants act or omissions during this event.

Your chili will be judged on appearance, flavor, and creativity. There are no guidelines on heat or composition of ingredients of your chili. We will be awarding a grand prize for the best chili and a runner up consultation prize for 2<sup>nd</sup> place.

We encourage everyone to decorate their booth and have fun with it. This is a family event so please keep all decorating appropriate.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMITY AGREEMENT in consideration of the vendor/artisan area at the Harvest Chili Cook-Off Festival located at the property of Taylor's Farm Market, LLC dba Cider Press Deli & Grill located at 178 Pilgrim Street, Inwood, WV 25428 on October 28, 2017.

## I hereby agree as follows:

- 1. To waive any and all claims that I have or may have in the future against Taylor's Farm Market, LLC dba Cider Press Deli & Grill, Robert W. Taylor, Ryan R. Taylor, the Harvest Chili Cook-Off Festival, and their employees and volunteers (all of whom are collectively referred to as the "Event Representatives") and to release the Event Representatives from any and all liability for any loss, damage, injury, or expense that I may suffer as a result of or arising out of any aspect of my use of the vendor/artisan area due to any cause whatsoever, including but not limited to, negligence or theft, or in respect of the provision of or the failure to provide warnings, directions, instructions, or guidance as to the use of the vendor/artisan area.
- 2. To hold harmless and indemnify the Event Representatives from any and all liability for any loss, damage, injury, or expense to any third party, resulting from the use of the vendor/artisan area.
- 3. This Agreement shall be effective and binding upon my heirs, next of kin, executors, assigns, administrators, and other similar parties, in the event of my death or incapacity.

I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ASSIGNS, ADMINISTRATORS AND OTHER SIMILAR PARTIES MAY HAVE AGAINST THE EVENT REPRESENTATIVES.

FURTHER, I HAVE READ AND AGREE TO ABIDE BY THE CHILI COOK-OFF RULES OF PARTICIPATION PROVIDED TO ME. FAILURE TO ABIDE BY THESE RULES OR ANY ADDITIONAL RULES OF THE EVENT REPRESENTATIVES RELATING TO THIS EVENT WILL RESULT IN DISQUALIFICATION WITHOUT REFUND.
