ON-GOING SUPPORT

The highly experienced support team at Head Office is 70+ strong and is dedicated to supporting franchisees in a range of different specialities, such as Business Growth, Marketing and IT.

CUSTOMER SUPPORT CENTRE

The in-house Customer Support Centre works on behalf of the franchise network such as restarting lapsed customers, increasing winter revenue and upselling our additional services. The conversion rate is high, with projected revenue in excess of £2million per annum.





PRODUCTS

Our technical team work in partnership with world-wide market leading manufacturers, to source and develop bespoke 'tried and tested' products, thereby ensuring only 'best in class' products are used throughout the network.

EQUIPMENT

PURCHASE AN EXISTING GREENTHUMB BUSINESS

With a franchise model created in 1997 and over 220 franchises, some of our franchisees have been trading for almost 20 years. Therefore, businesses come up for sale for various reasons including retirement, relocation, or the franchisee simply wants a return on their initial investment.

TERRITORIES

Franchise territories have been carefully constructed considering demographics, socio-economics and geographical analysis. The success of a franchise is measured by market penetration - the number of customers as a percentage of the number of detached and semi-detached homes in that area. The highest penetration in a single territory is 14% (so far).

SECOND PHASE - FINAL APPROVAL

It is likely that you will have a lot of questions. We have endeavoured to bring together some of the most frequently asked questions regarding franchising with GreenThumb.

If your question isn't listed below, please do not hesitate to get in touch.

Q. Are there any virgin territories in my area still available?

A. We have limited virgin territories for sale in SW Scotland, S Wales and Norfolk; please contact the franchise sales team for availability in your location. If you are willing to re-locate we could have an area to suit you.

Q. Can I purchase an existing GreenThumb branch?

A. Yes, due to us having coverage of most of the UK, the majority of our franchise sales are re-sales. The most common reasons for a GreenThumb business coming up for sale are retirement, return on investment or a change of circumstances.

Q. Do I pay monthly fees?

A. The monthly fees consist of 7% Continuing and 3% Marketing fees.

Q. Is GreenThumb a seasonal business?

A. GreenThumb is an all year round business, with winter work proving to be most profitable.

Q. Can my customers pay by Direct Debit?

A. Yes, Direct Debit has been introduced by GreenThumb allowing customers to spread the cost, steadying your cash flow throughout the year and, more importantly, increasing your profits!

Q. Are franchisees expected to experiment with new ideas?

A. GreenThumb own a number of corporate branches. These franchises are run from our Head Office and ensure our franchisees are not the guinea pigs. We establish best practice within these businesses before rolling it out to the network.

Q. How long does the new franchise training course last and where does it take place?

A. GreenThumb training courses take place at our Head Office in North Wales and last for 13 business days.

Q. How much will I earn?

A. You will get out of your business what you put in. Our most successful franchisees follow the Method correctly and reap the benefits from doing so.

Q. What qualifications do I need to run a GreenThumb franchise?

A. This is a management franchise; we are looking for investors who will drive the business, provide exceptional customer service, and who possess the motivation and determination to grow their business.

Q. Can I have more than one franchise?

A. Some of our franchisees do have multiple territories; you would have to satisfy a certain criteria to be granted the option to purchase a further territory, and would need to demonstrate that you have the infrastructure to facilitate the extra customer numbers.

Q. Can I sell my franchise?

A. Yes, you can sell your franchise at any time, however, we recommend that you grow your business sufficiently to realise your initial investment.

Q. What are the next steps?

A. You can make contact with the franchise sales team here at GreenThumb who will advise you if we have a territory available in your preferred location. If so, you would then proceed to apply for a franchise by way of completing our application form online and proceed to upload a copy of your CV.
