

Get to know your Hand IQ Smart Badge



Smart badge LED and audio indicators

LED and audio sequence

Red, green, blue - 3 blink and 3 beep sequence Smart Badge turns on for the first time when the battery is added.



Blue - 2 blink and 2 beep sequence

Smart Badge reminds a person to wash their hands when the badge wakes up (someone puts it on) and based on the handwash intervals set by management.



Blue - 4 blink and 4 beep sequence


Smart Badge reminds a person to wash their hands a second time and they have 5 minutes to wash their hands before it's a missed opportunity.



Getting started


Prepare the Smart Badge

 Remove the back of the Smart Badge by sliding the back cover away from the badge. Next, insert battery with its positive terminal facing you. The Smart Badge's LED should flash red, green and blue on the front, and you should hear three beeps.



Add your Smart Badge clip

- You should recieve a bag of clips based on your order. There are three types of clips that work with the Smart Badge. A pin clip, a magnet clip, and a spring clip.
- Each clip comes with an adhesive backing that attaches to a different area on the back of the Smart Badge. The pin clip and the magnet clip are mounted to the horizontal indentation on the back badge. The spring clip is mounted to the vertical indentation on the back of the badge.



App setup

Assign Smart Badge to a location

Smart Badges need to be assigned to a location, but don't have to be assigned to a specific person.

For example, a restaurant might have 20 staff, but only 5 working at a time. A badge can be picked up when a shift starts. It will then wake up and begin reminding the staff member to wash hands based on a location's settings. This way you get the advantage of proactive reminders without singling anyone out.

However, you can always assign a badge to a location and staff for individual accountability and healthy competition. It's up to you!

Open your Hand IQ app and select "Badges" on the navigation bar



- Set the badge you are going to assign to the location near your mobile device (within 6 inches).
- Click "Find / Add Badge" in the upper right corner. The badge nearest to your mobile device should appear. If there are multiple unassigned badges that appear, you can click "assign" to one of them and then click "test". The unassigned badge will beep. You will then know which badge you are using.
- Next, you can name the badge or leave it unnamed. If left unnamed, the app will assign a number to it.

You can add up to 50 badges to your location. If you assign badges to staff members by name, you can review compliance reports for each staff member on the app and also have reports sent to your email inbox.
