ROI Business Case

At 100% utilization: \$655,200 divided by cost of \$13,000* per year = annual ROI 504% At 75% utilization: \$491,400 divided by cost of \$13,000* per year = annual ROI 378% At 50% utilization: \$327,600 divided by cost of \$13,000* per year = annual ROI 252% At 25% utilization: \$163,800 divided by cost of \$13,000* per year = annual ROI 126%

You may finance or lease the pod with zero-down 60-months at approx. \$1500/month and pay off the entire pod within several months. Your light pod will qualify for a section 179 IRS tax deduction of approximately \$5,000 per year *.
