The undermining of family and marriage

- 'The feminists on Closing the Gender Gap- representative of a broad swathe of opinion in feminist education circles and influential on government policy- are pleased that girls, and working-class girls in particular, are leaving the domestic sphere of home and hearth and becoming increasingly independent of men through work. The education feminists think that this is the only way girls can gain status. It is only in the world of men- work, the public sphere- that women can find fulfilment and happiness, the same as it is for boys and men.'6

- 'The government has thrust children forward as its shield of moral valour. Yet the interests of children are best served if their natural parents are married; the poverty of children is significantly caused by their parents, failure to remain so. Behind its child-centred rhetoric, the Labour government is actively discriminating against the one family structure that actually benefited children, pretending to a false even-handedness while creating instead a feminised model of the family that is making men literally and metaphorically redundant.'7

The social consequences of feminist 'social justice'

Divide and Rule

'By the beginning of the 21st century, the movement known as feminism had fragmented. The dream of a united sisterhood had never come to pass; indeed the tabloids were able to revel in vicious infighting between supposed 'sisters'. The so-called sameness feminism of the 1960s was soon taken over by the difference feminism of the 1980s (women are the superior sex!) and there was now a major backlash against feminist ideas in the 1990s. It is now said that we live in a post-feminist era,'8

The State takes over

A UNESCO document on population control and the need for sex education, published in 1978, suggests that younger age groups are 'appropriate targets' and that 'the school, with its captive audience,' is 'the obvious place to start'9

'It is the themes of the early Greer, Steinem and Friedan-that independence and career are what are most important to a girl, that marriage, children and family are just so much domestic drudgery- that match the curriculum and emphasis of schooling for girls today...'

Beyond Culture

'When the Bible teaches that men and women fulfil different roles in relation to each other, charging man with a unique leadership role, it bases this differentiation not on temporary cultural norms but on permanent facts of creation. This is seen in 1 Corinthians 11:3–16 (especially vv, 8–9,14); Ephesians 5:21–33 (especially vv, 31–32); and 1 Timothy 2:11–14 (especially vv, 13–14). In the Bible, differentiated roles for men and women are never traced back to the fall of man and woman into sin. Rather, the foundation of this differentiation is traced back to the way things were in Eden before sin warped our relationships. Differentiated roles were corrupted, by the fall. They were created by God.11

Teaching a Biblical Worldview

This is a heart issue

"...in winning people over to a vision of manhood and woman hood, not only must there be thorough exegesis, there must also be a portrayal of the vision that satisfies the heart as well as the head. Or to put it another way: we must commend the beauty as well

as the truth of the vision. We must show that something is not only right but also good. It is not merely valid but also valuable, not only accurate but also admirable.'12
