## **Accent Release Powder**

**EZCURB** Accent Release Powder is a blend of fine pigments and water repelling additives designed to prevent freshly placed concrete curbs from adhering to stamping skins and texture rollers. The Accent Release Powder transfers the details of stamping skins or texture rollers to the freshly placed curb in matching or contrasting colors. These colors are used on plain or integrally pigmented curbs.

## **BENEFITS:**

- Creates accent stamped texture lines (dual color tone) on curbs
- > Prevents adhesion of the concrete to stamps or texture rollers
- Provides accurate texture detail transfer
- > Available in 9 colors

**DIRECTIONS FOR USE:** Place and finish the curb surface as required. When excess moisture has dissipated, broadcast a thin layer over the curb surface. Stamp skins or texture rollers may be used immediately following the application. Removal of the excessive powder can take place after the curb is sufficiently hard and the surface cannot be damaged. Sweep the excess material of the curb's surface and rinse excess off with a *light* scrubbing. Take care not to damage the curb surface during this step. After the curb dries thoroughly, apply either the **EZCURB SATIN or GLOSS SEALER** to protect and enhance the newly placed textured curb.

**COVERAGE:** Approximate coverage rate is 2 pounds per 100-150 linear feet. One 25 lb. pail should cover over 1,500 linear feet.

**CAUTIONS:** Be aware of wind conditions when applying. In colder temperatures allow more time for the concrete to cure before removing the excess *Accent Release Powder*. Be careful not to stain surrounding areas with excess rinse water during removal of residual.
