**COVERAGE:** Approx. 100-150 sq. ft./gallon. Actual square footage will depend on dilution rate used as well as method of application

**DIRECTIONS FOR USE:** Always test an area before overall application of *Green EZ™ Eco-Clean* to determine suitability and results.

**SUGGESTED DILUTION / USE RATIOS: Dilute 1:1** by volume with clean potable water for normal stain removal. For tougher, heavily deposited residuals use *Green EZ™ Eco-Clean* at full strength.

**APPLICATION**: Apply the diluted or concentrated solution generously to the surface to be cleaned by simply by pouring or spraying onto horizontal surface. Spread and agitate lightly with a brush, Allow the *Green EZ™ Eco-Clean* adequate time to dwell, typically 1 hour, scrub again and remove with wet vacuum. Rinse the surface with water, wet-vacuum and check surface for residue. Additional rinsing may be required.
