## **INTEGRAL WATER REPELLENT ADMIXTURE FOR CONCRETE & MASONRY**

**PRODUCT DESCRIPTION:** *Specco W-33* is an integral water repellent liquid admixture used in concrete blocks, pavers, roof tiles, and related precast, as well as mortar and stucco mixes. *W-33* provides added water repellency, and aids cement hydration to provide increased compressive strengths and improved freeze thaw resistance. *W-33* is formulated to reduce cracking, crazing, efflorescence, surface bleeding, and to help provide uniform color to pigmented mixes. *W-33* is viscosity modified, allowing the active ingredients to remain in the concrete matrix and not separate or float to the surface during mixing.

**COMPOSITION:** Viscosity modified stearate-based solution. *W-33* does not contain any calcium chloride or intentionally added chlorides that would initiate or promote corrosion of reinforcement steel or contribute to efflorescence.

**TECHNICAL DATA:** *W-33* is compatible with most mineral and chemical components common to Portland cement, calcium alumna cement and calcium sulfate (gypsum).

DIRECTIONS FOR USE: It is recommended that the *W-33* be added directly to the mixing water. Dosage is 1 quart (32 ounces) per bag of Portland Cement (2080 ml per 100 kg). Add 16 oz. per 100 lbs. of hydrated lime (1040 ml per 100 kg). Higher dosage rates will improve both bond strength and absorption reduction.

**CAUTIONS:** *W-33* integral water repellent should be tested and evaluated with actual materials and blending processes to gauge overall performance and compatibility with mix components. *W-33* will reduce penetration and may affect related inter-coat adhesion of subsequently applied water-based stains, paints, or topcoats. W-33 is water based and will freeze at 32° F. Material may be completely restored by thawing at room temperature and mechanically agitating thoroughly. *W-33* should be stirred before using if the material has set for an extended period (3-6 months).
