# **Not Just Pets inc Group Grant Requirements**

#### **Financial Documentation:**

Group applicants, such as rescues, shelters, or other organizations involved in the care of animals, must submit proof of financial hardship. This may include recent financial statements, tax returns, or a detailed letter explaining the organization's financial situation.

#### **Income Threshold:**

To qualify for assistance, the group must have a total annual income of \$150,000.00 or less.

#### **Explanation of Hardship:**

Provide a detailed explanation of the circumstances leading to the financial hardship of the group, including any relevant information that supports the request for assistance.

#### **Review Committee:**

A review committee within Not Just Pets Inc. will assess each group application impartially to ensure that assistance is directed to those with genuine financial need.

#### **Applicant Commitment:**

Groups must showcase a commitment to responsibly care for the animals under their care in the future. Provide a plan for ongoing veterinary care, responsible pet ownership, and the overall welfare of the animals.

#### **Impact Statement:**

Include a statement on how the assistance from Not Just Pets Inc. will impact the well-being of the animals within the group.

#### **Communication and Follow-Up:**

Agree to provide follow-up information and periodic reports on the health and well-being of the animals if assistance is granted.

#### **Anonymous Assistance:**

Groups can request anonymous assistance if they are uncomfortable disclosing certain details but can provide sufficient evidence of financial need.

#### **Non-Discrimination Policy:**

Not Just Pets Inc. is committed to providing assistance without discrimination based on race, gender, religion, or any other protected characteristic. If there is an animal involved, that is what we are here for.

### **Application Deadline and Processing Time:**

Group applications must be submitted within a year from the initial contact. Please allow up to 2-4 weeks for the review and response of the application.

#### **Submission Instructions:**

Ensure all required documents are attached to your application. Incident must be within one (1) year from submission. Submit the completed application via E-mail.
