Global Doctor Privacy Notice – Last Updated 22 November 2022

Align Technology Inc. and its associated companies ("Align", "we", "us"), are committed to protecting your personal information (in this privacy notice, "information" refers to the personally identifiable information, considered personal data, that you provide, or we collect on, about, or from a customer through our websites).

Align designs, manufacturers and markets the Invisalign®system, iTero™ intra-oral scanners and orthocad services, My Invisalign™ App, which enables users to track and share progress whilst undergoing Invisalign® treatment by uploading images, sharing stories, creating appointment reminders and receiving notifications as well as Invisalign Practice App, which is integrated with the Invisalign Doctor Site to help streamline the practice workflow by putting many of the Invisalign treatment features like Invisalign Photo Uploader, Virtual Care (in applicable markets), Virtual Appointment and Smileview™ simulation in one convenient app (the "App").

This notice describes how Align collects and handles your personal information when you register as an Invisalign trained doctor or purchase an iTero scanner, or when you use our websites and our App. Whilst Align Technology Inc is the collector of all personal information submitted through the Invisalign Doctor Site, the data controller of your personal data will be the Align entity with which you have entered into an agreement in order to register as an Invisalign trained doctor or purchase an iTero scanner. If you are a prospect and are participating any Align event or webinar, we may ask if you are willing to be approached by Align's sales representative, the data controller of your personal data will be Align Technology Inc. as your personal information will be collected and stored in our global CRM system. In some cases, the third-party organizer who holds the Align event or webinar you have registered to may also be a data controller, and your personal data will be subject to the third party's own privacy notice. Please make sure you consult this privacy notice prior to registering to the event.

Please Note: Certain jurisdictions require us to include additional information to meet jurisdiction-specific requirements. Such jurisdiction-specific terms are contained in the following appendices and are incorporated by reference herein. In the event of any conflict between the terms of this Notice and the terms of an Appendix regarding personal information subject to that Appendix, the terms of the Appendix shall prevail.

Personal information we collect and how we use it

Align will collect, store, and use your personal data such as your name, address, phone number, practice details, your use of our services, email address, identification documents, bank accounts details, your Practice Certificate or national identification number, user behaviour on Align products, website, or mobile applications, unique device number (Android ID or UDID) and any personal information as may be required for a particular purpose or that you voluntary disclose to us (including such information as orders placed and your treatment planning preferences), and qualifications ("Personal Data"). Our legal basis for collecting and using the personal information described above will depend on the personal information concerned and the specific context in which we collect it. In principle, we will process Personal Data based on the informed consent we receive from you, however, where applicable we will process Personal Data in accordance with the legal basis below.

The processing of your personal information is sometimes necessary for us to do the abovementioned activities, in our own interest or sometimes in the interests of a third party, like patients or prospective patients. In each case, we balance our legitimate interests with your rights and interests.

Our legitimate interests include:

- Delivering, developing and improving our Sites and communications.
- Growing our business and informing our marketing strategy.
- Keeping our records updated.

• Providing you with our promotional updates and communications in certain cases where you have made purchases with us and have not opted-out at the time of purchase or any time since.

If we ask you to provide personal information, we will make this clear at the relevant time and advise you whether the provision of your personal information is mandatory or not (as well as of the possible consequences if you do not provide your personal information).

There may be features on the Sites for which provision of your personal data to us may be mandatory, to comply with a legal requirement or to perform a contract with you and if so, where you do not provide us with the required information, we may not be able to provide you with the associated products and/or services.

On occasions you may choose to provide us with personal data about other people (e.g., your patients) so that, for example, we can manufacture customized products for orthodontics or restorative purpose as ordered and authorized by you. We will act as a processor with regards to such personal data of your patients, subject to the terms of the Invisalign Pricing Terms and Conditions, Global Data Protection Addendum.

Who we share your personal information with

We partner with other businesses who provide services to us such as the provision of technology or to assist us in our marketing, communications, and sales efforts, and may share information about you for these purposes. These partners are not allowed to use your information for any purpose other than doing business with Align.

For Customers who are members of a Dental Services Organization ("DSO") or group practices, Align may also share information about your Invisalign or iTero usage, submission history, interaction with Align technicians, and other statistics with your DSO or group practice as part of Align's regular accounting, analysis and reporting.

In addition, any information we collect, including personal information, may be disclosed to a third party (and their agents and advisers) as part of any actual or potential merger, acquisition, debt financing, sale of company assets, or similar transaction, as well as in the event of insolvency, bankruptcy or receivership in which personal information could be transferred to third parties as one of our business assets.

We may also disclose personal information about you to any competent law enforcement body, regulatory, government agency, court or other third party if we believe that doing so is legally required or is necessary to protect our property or other legal rights (including but not limited to enforcement of our agreements or the rights of others).

We may also share your information with other third parties if you consent to us doing so or if permitted under applicable law.

International data transfers

Align operates globally and may therefore transfer your personal data to other countries in which Align operates, including countries other than your country of residence. Your personal data may also be stored on our servers, which may be located outside your country of residence. Our third-party service providers are also located in these countries across the world. If you are a resident of the European Economic Area, Switzerland and/or the United Kingdom please note that we may transfer your information outside of the European Economic Area, Switzerland and/or the United Kingdom to our service providers and partners, and we ensure that your information is adequately protected for example by ensuring that the standard contractual clauses are used or any other approved transfer mechanism. By providing us your personal data, you agree to such transfers, processing and/or storage anywhere in the world, including the United States.

Retaining and deleting your personal information

The Align group will retain your personal data for only as long as it has an ongoing legitimate need to do so, for example, to provide you with goods and services, and to comply with regulatory obligations. The personal data will then be either deleted or anonymised or, if this is not possible (for example, because your personal data has been stored in backup archives), then they will be securely stored until deletion is possible. Upon expiration of the specified retention period and after obtaining any necessary approvals, your personal data will be destroyed by means appropriate to their nature or level of confidentiality, e.g., shredding, recycling, or deleting.
