



## TOURNAMENT REGULATION AND FUNDAMENTALS

### GENERAL FOUNDATIONS

1. The International Tournament of Sportfishing "BAJA BLUEFIN TUNA TOURNAMENT" by PESCA DEL MAR \*OUTDOORS\* will be held from Friday, May 10th to Sunday, May 12th, 2024 in Ensenada, Baja California, Mexico.
2. The competition will be carried out in teams of six people including the captain, additional to these six members, the teams can add four people extra according with the guidelines of this Regulation and having maximum of ten people per boat.
3. The competition will be won by the team that obtains the highest sum of weight (pounds or kilograms) of the Bluefin Tuna catch within two fishing days, it does not matter if showed up a catch just in one or both fishing days, what matters is the accumulated weight, as long as it has a minimum weight of 20 pounds (9.07 kilograms) per specimen.
4. In the event that there is no Bluefin Tuna (Bluefin) catch, the species that will participate will be the following: Yellowfin Tuna, Yellowtail, White Sea Bass, Mahi Mahi (Dolphin fish), Marlin, Swordfish, California Sheepshead, and Giant Grouper (Black Sea Bass). As long as it has a minimum weight of 15 pounds (6.81 kilograms), in the case of billfish, the minimum acceptable weight will be 100 pounds (45.36 kilograms). These species will be the only ones allowed to participate in the tournament. The winner team will be the one that presents any of the aforementioned species with the highest accumulated weight.
5. As this is a tournament focused on the capture of Bluefin Tuna (Bluefin), the awards will give priority to this species, so if a single Bluefin catch with the minimum required weight is presented on day one or two of fishing, it will be placed at the top of the table of catches regardless its weight is less than the species mentioned in point number 4 of these foundations.
6. Each team will have the right to show up only one specimen per fishing day as long as it complies the minimum weight aforementioned in point number 3 of the general foundations of this regulation and also forms part of the list of species allowed for this Tournament. Species that are not described in it will not be allowed, furthermore to being prohibited species or subject to protection by the competent authority.



7. Table of prizes for the three teams with best weighing capture.

<b>3rd Place</b>	2 Combos (Rod and reel) Okuma Makaira and one Killbag from Reliable Fishing 42" x 90"	\$4,500 USD

For the delivery of the prizes, the teams must agree the physical delivery with THE ORGANIZING COMMITTEE, so it will be on schedules and working days, in the facilities of THE ORGANIZING COMMITTEE. In case of being the winner of the boats, it is important to remember that the prize does NOT include trailer, so the winners will have to go to the facilities of THE ORGANIZING COMMITTEE with their own trailer and thus be able to make the formal delivery of the prize.

8. The base registration will have a cost per team of \$990 USD (Nine hundred and ninety U.S. Dollar) until April 30, 2024 entitled to board up to 5 (five) fishermen and the captain (total six people) on the boat. In case you need take more fishermen on the boat, you can take up to 4 additional fishermen, as long as the regulatory capacity of your boat allows it and must be pay an extra fee as described below:

\$200 USD per extra fisherman, up to a limit of 4 extra fishermen.

Registration from May 1st, 2024 until the event day will be \$1,350 USD per team entitled to board up to 5 (five) fishermen and the captain (total six people) in the boat. The cost for additional fishermen does not change.

9. There will be "Jackpot" in this competition, which will be classified as follows:

Jackpot Category	Amount per day of fishing
Diamond	\$10,000 pesos or \$600 USD
Gold	\$5,000 pesos or \$300 USD

**Jackpot Policies:**

A) The winner team of the Dairy Jackpot in each category will be the one that presents the best catch by weight of Blue Fin Tuna, or alternative species according to the guidelines of point number 4 and 5 of the general foundations of this regulation.

B) Accumulated Jackpots and awards are for each day of fishing. In other words, there will be an accumulated from day 1 of fishing and another from day 2 of fishing, for each category.

C) If you decide to participate in the Jackpot, you may participate in one or both categories (Diamond or Gold), with the possibility of being able to obtain prizes for each day of fishing in each category of Jackpot in which you participate.

D) In case of deciding to participate in one or both categories, it is mandatory to participate in the Jackpot of both days of fishing, that is, the Jackpot of day 1 of fishing and the Jackpot of day 2 of fishing of each category in which it is decided participate.

Example: In the event that a team decides to participate in both categories (Diamond and Gold), the team must have on hand the amount of \$30,000 pesos or \$1,800 USD.

E) Payment of the Jackpot must be in cash, it may be in Mexican Pesos or U.S. Dollars (USD) according to the table of Jackpot categories, and must be paid on the same day of registration.

F) Awards will be delivered in cash in Mexican Pesos and U.S. Dollars (USD) according they have been accumulated, the winners will not be able to demand equivalences in a single currency, if the winners wish to have the cash prize in a single currency they must exchange their cash outside the event, relieving the organizers from that responsibility.

G) Participating in the Jackpot is not mandatory, if the teams wish, they can enter to one or both categories for the sole purpose of increasing their possible winnings.

H) In case there are no catches of Bluefin Tuna or any other species allowed for this tournament, the Jackpot will be declared void and THE ORGANIZING COMMITTEE will refund to each of the teams their respective bets.

I) In the event that the Jackpot is declared void, the refund will be made the next business day after the end of the tournament. In case of any eventuality, THE ORGANIZING COMMITTEE will have a maximum of one week to refund the cash. The refund will be made at the offices of THE ORGANIZING COMMITTEE in Ensenada, Baja California, Mexico.

J) In order to cover the risks and costs of safeguarding the cash generated in the tournament, THE ORGANIZING COMMITTEE will retain 10% of the Jackpot accumulated, or in case of cancellation, only 5% of the Jackpot will be retained.

10. The boats that can participate in the tournament will be all those boats that are focused or adapted to sport fishing, regardless of the size of their length.

11. The only boats that will not be able to participate in the tournament are “commercial fishing vessels” that by their nature and construction are focused on commercial fishing.

## 12. Donations and Social Impact

With the sole purpose of having a positive impact on society and encourage altruism, THE ORGANIZING COMMITTEE will accept VOLUNTARY DONATION of catches by the teams. A public recognition will be given to the teams that decide to donate one or more catches during the tournament. The catches will be donated to places of humanitarian aid, such as a home for the elderly, DIF (National System for the Integral Development of the Family), and/or lodging for minors, etc. as donations allow.

There will be an exclusive raffle for the teams that decide to donate, which will be announced on the day of the awards.

## TOURNAMENT REGULATION

### 1.-Acceptance of rules

It is the responsibility of all participants to read carefully the Foundations and Rules of this tournament, and that at least one representative of the team is present at the Captains Meeting, otherwise the team accepts the agreements, including those that imply modifications to this regulation.

### 2.-Registration and Fishing Permit

All persons aboard the boat must be registered for the tournament and carry their printed Mexican sport fishing permit, which can be purchased online at the following link: <https://tramites.ebajacalifornia.gob.mx/ventanillaunica/tramites/pesca>.

### 3.- Proper documentation of the boats

Each participant is responsible for ensuring that their boats, whether national or foreign, have their documentation in order, according to the provisions of the competent agencies. It is recommended that in case of having a boat with another country's flag, arrive a couple of days before to carry out any required procedure or permit.

### 4.- Relieve of responsibility for THE ORGANIZING COMMITTEE

It is not the responsibility of THE ORGANIZING COMMITTEE that the competent authority: the Port Authority, Navy, CONAPESCA or any other agency, prohibits any boat from going fishing for not having the corresponding documents in order. We suggest reviewing what are the required documents for your boat to navigate freely through Mexican waters.

### 5.-Participation by teams

Participation of the tournament is by teams and each team must designate and register an official representative, who will be the person who can claim any type of situation that may arise regarding registration, weigh-in, awards, official protest, Jackpot, etc., approaching at all times with THE ORGANIZING COMMITTEE. At the moment that a team is officially registered with its name and folio, it will not be able to modify that information.

### 6.-Validity of registration

For the registration to be fully valid, the official representative of the team must be present on the day of the tournament registrations to cover the total payment of the registration fee, in case they

have not done it online. They must also deposit at that time the amount of the Jackpot they have chosen. It is mandatory to present the valid Mexican sport fishing licenses of each of the participants, as well as the registration form duly filled out. Once the above is completed, you will be given a registration voucher, as well as the foundations, official regulation, bracelet and security bands to tag and label the catches.

### **7.-Decision of the judge**

The decision of THE SCALE JUDGE and, where appropriate, of THE ORGANIZING COMMITTEE that for the purposes of this tournament is integrated, is unappealable.

### **8.-Fishing equipment to be used**

The fishing equipment that will be allowed is: rod, reel and fishing line of your choice (Bent butt rods are allowed). Electric reels or any assisted fishing equipment are strictly forbidden for the capture of the species.

### **9.-Only permitted use for the electric reel**

The use of the electric reel will ONLY be allowed for those teams that decide to use the kite as fishing set up. The kite may be connected to an electric reel with the only purpose of being able to retrieve it (the kite) faster, but the hooking and the battle with the catch must be on a manual reel, without any exception.

### **10.-Bait**

The teams will be able to capture live bait before the start of each fishing day if they wish, however, the boats must be ready and aligned for the starting shot of each fishing day without exception, otherwise they may be deserved to a sanction. (See point number 19 of this regulation).

It is understood that the capture of bait is what allows you to capture the Sabiki or similar fishing gear in a period of time, no boat should have large amounts of live or dead bait, since this will be interpreted as a possible intention to fish through the chumming, which is strictly prohibited. Any boat registered in the tournament that is caught practicing the chumming will be disqualified.

The inspectors who review the boats will have the authority to determine if the quantity of live or dead bait that is carried in the boat is with a possible intention of practicing the chumming.

In case of using live bait, you can only use one bait per rig and per fishing rod, if any team is surprised in the videos using more than one rig on the fishing lines, that catch will be disqualified.

### **11.-During the battle**

During fishing, once the fish bites the bait, lure or hook and gets hooked, it must be work and approach to the boat, with no more help than the reel, rod and fishing line. As this is a tournament by teams, it is allowed to support or help any member who is in the battle with the catch. It will also be allowed to relay the angler during the battle, as well as support the rod on the rail as long as it is not in the boat's rod holders.

The use of chairs, belts, battle vests and harness are allowed, as well as the skill of the captain for the management of the boat at the time of the battle.

### **12.-Bats and/or nails**

It is strictly forbidden to hit the catch in order to stop it from moving, to avoid hurting the specimen to be shown. In case THE SCALE JUDGE detects bruises on the species, it could be disqualified, having a second opportunity to show another captured species, as long as it does not present the same bruises or blows as the one previously shown. The only way to make the catch stop moving is to drive, either manually or with a hydraulic gun, a nail into the head of the fish, as long as this is done in only one attempt.

### **13.- Bleeding of the captured species**

In the case of Bluefin catches, all specimens to be presented must be bled, all teams must comply with this rule to have access to the weighing scale.

Failure to comply with this rule will result in the teams having to submit another catch.

How to bleed tuna?

The pectoral fin should be identified. Once identified, they must raise it and, following its same line, two centimeters after the fin must be bury a knife not deeper than two centimeters into the tuna, with this the artery that runs through its pectoral fin will be cross and the tuna will begin bleed. This same procedure must be done on the other side of the tuna, namely the tuna must have two incisions, an incision on the left side as well as another on the right side. THE SCALE JUDGE will review the incisions of the catches so that they meet the two-centimeter depth requirement. In case of not complying with this rule, THE SCALE JUDGE could disqualify said capture.

#### **14.-Presentation of catches on the scale**

It will be the responsibility of each participating team that, through its official representative, present its catches on the scale.

#### **15.-Weighing**

No specimens will be weighed out of courtesy, and only one piece will be weighed per team per day of fishing, which must be chosen by the same team.

For the award, the sum of the total weight in pounds and/or kilos of the species presented will be taken into account. In case of a draw, it will be decided under the following guidelines and respecting the order that is presented below:

- A. In the event of a draw in the sum of weights, the winning team will be the one that has registered the specimen with the highest weight in pounds or kilos before THE SCALE JUDGE either on day one or two of fishing.
- B. In the event of a draw in the sum of weights as well as a draw in the weight of the largest specimen, the team that has presented its largest catch first before THE SCALE JUDGE will win. Thus, the registration time of said species will set the guideline for the winning team.

Any liquid, blood or anything that is an integral part of the catch (fish) falls due to GRAVITY at the time of the weigh-in, is excluded and no claim can be made to THE SCALE JUDGE nor to THE ORGANIZING COMMITTEE for such loss that could affect the weighing.

#### **16.-Weighing receipt**

At the weigh-in registration desk, the team representative will be given their weigh-in receipt, and it will be the responsibility of the representative to verify that the information (Team Number or Name, Time of Weigh-in and Weight) is correct, consequently, subsequent changes will not be accepted.

In the event of any error in the registration system, the team representative must present the original receipt of the weigh-in in question and make the corresponding clarification.

#### **17.-Catch record**

To register the catches, the teams must appear personally before THE SCALE JUDGE, showing their registration bracelet.

It is prohibited to present catches that arrive at the weighing area by land, even due to force majeure or in fortuitous cases.





## **18.-Tournament Schedule**

### **Day 1, Friday, May 10th, 2024: Registration**

Registration opening time: 1:00 pm

Opening ceremony: 5:30 pm

Captains meeting: 6:00 pm

Registration closing time: 8:00 pm

### **Day 2, Saturday, May 11th, 2024: First day of fishing.**

Boats review time: 04:00 am onwards

Starting shot: 05:00 am approx.

Scale opening: 2:00 pm

Scale closing: 5:00 pm

### **Day 3, Sunday, May 12th, 2024: Second day of fishing.**

Boats review time: 04:00 am onwards

Starting shot: 05:00 am approx.

Scale opening: 1:00 pm

Scale closing: 4:00 pm

Awards and closing ceremony: 6:30 pm approx.

THE ORGANIZING COMMITTEE will be the only one authorized to make any changes to the schedules established in this regulation, be it in fortuitous cases or for convenient strategies for the tournament.

THE SCALE JUDGE will not receive, nor weigh, any specimen after the scale has been closed according to the official clock of the tournament, only those fishermen who are already in line awaiting their weighing will be registered. There will be an official clock in a visible place to all, by which THE SCALE JUDGE and the participating teams will be governed.

## 19.- Starting shot

All boats must be ready and in starting position at the time of the starting shot, which is specified in point number 18 of this regulation. No participating boat may leave before the start time. The tournament surveillance boat will be at the end of the breakwater to verify that no team leaves early.

In the event that a team is detected leaving early, that team will be penalized 20 pounds in the total weigh-in report. This applies for both, tournament and Jackpot awards.

## 20.- Speed inside the breakwater

All boats without exception must respect the speed limits imposed by the maritime authorities. During navigation within the breakwater, the speed limit is 5 miles or 4.3 knots. It is important to be aware that the wake of water left by boats can be dangerous for other boats behind them. Therefore, it is recommended that you exercise extreme caution and respect the speed limits.

Once out of the breakwater, the boat may sail at the speed they consider convenient, as long as they take care of the safety of their crew.

## 21.-Fishing time

In point number 18 of this regulation the fishing schedules are mentioned, these schedules are final and only THE ORGANIZING COMMITTEE can make adjustments in case it considers convenient.

## 22.-Photography and video verification

All teams must have digital video files of **AT LEAST** 10 minutes, and it will be a mandatory requirement to continuously show the following requirements:

- A. Once the video has started, it must be said in the voice of one of the participants: Date, Hour and Name of the team.
- B) Show the surroundings of the boat in a 360-degree turn, in which there should be no tuna fattening pens on the horizon, nor boats at a distance of at least 10 meters (3 feet). In the event that the image of the horizon is not appreciated clearly or with a sharp image, this video together with its capture will be disqualified.
- C) Show the battle and approach of the capture to the boat at a minimum distance of 5 meters (17 feet), showing the complete body of the specimen.
- D) Show when the catch is brought aboard the boat.

- E) Showing the catch dominated on the deck of the boat with the lure or fishing gear attached, a length of line or leader, as well as the rod and reel equipment used. Thus, showing that the rod contains the line and the lure of the catch.
- F) THE ORGANIZING COMMITTEE will give a bracelet to each participant of the team, the video must show the bracelet on the fisherman who is in the battle with the catch.
- G) The video must show the moment where the tag with a folio (strap) is placed on the tail of the catch, the same tag with folio that THE ORGANIZING COMMITTEE will deliver to each team at the time of registration.
- H) The video should not have shorts, pauses, or interruptions that could suggest a possible edition.
- I) The video file must be configured with the correct time and date according to the time zone of the tournament venue.

**NOTE:** THE ORGANIZING COMMITTEE will give each of the teams the amount of two tags with folio (strap) per participant, per day of fishing.

For example: if the team is made up of 3 members, the team will be given the amount of 12 tags with folio.

(3 members x 2 fishing days x 2 tags with folio= 12 tags with folio)

**IMPORTANT NOTE:** The battery charge and storage in the memory of the video cameras, cell phones or any other recording equipment with which the shots are taken, are responsibility of each team. The aforementioned or any other reason that could be argued is not an excuse for NOT hand the video as evidence of the capture for the tournament.

The lack of this evidence is grounds for disqualification of the catch presented.

All teams must bring their data transfer cable (with USB connection for computer) to be able to download the evidence video on the computers of THE ORGANIZING COMMITTEE, which is not responsible for not being able to receive your video due to lack of the necessary tool.

**NOTE:**

THE SCALE JUDGE may request at his discretion the video and photographs of the team representative at the time of the weigh-in, in order to clarify any doubts observed.

### **23.-VIDEO evidence for potential winners of tournament awards and Jackpot**

THE SCALE JUDGE will require recording evidence from the potential winners per day of fishing, for the tournament and Jackpot prizes, such videos are mandatory without exception. At the time of the last weigh-in, the representatives of each team must remain in the weigh-in area for the review of their video in case it is required because they are at the top of the standings. The teams will be called and their representatives will have a maximum of 30 minutes WITHOUT EXCEPTION to present their video to THE SCALE JUDGE.

THE CAPTURE OF THE TEAMS THAT DO NOT PRESENT SUCH EVIDENCE WITHIN THE TIME LIMIT WILL BE DISQUALIFIED.

In the event that any team is disqualified for the aforementioned reasons, video evidence will be received from the next place in the weigh-in table.

Example:

If the first classified does not present evidence, the evidence of the second classified in the table will be required, who could occupy the first place.

If the 2nd classified also does not present evidence, the evidence of the third classified in the table will be required, who could pass to occupy the 1st place and so on.

The same applies to tournament awards, 2nd place can move to 1st, 3rd to 2nd and so on.

### **24.-Navigate near tuna pens**

It is strictly forbidden to navigate around pens of the different tuna companies in the region, therefore it is stipulated that no boat may be fishing less than 3 nautical miles from the tuna pens. Ignoring this rule is automatic disqualification, thus losing any chance of participating for any prize or any Jackpot.

THE ORGANIZING COMMITTEE will have alliances with fishing companies and boats to report any boat hovering around tuna pens. We want this to be a fair tournament, so we suggest you adhere to these rules, do not risk your qualification in the tournament.

### **25.-Navigate near another boat**

It is strictly forbidden for a boat to be right next to another even in fortuitous cases. In the event that a boat is next to another, it must be for security or medical emergency, which must be reported and approved in the channels or frequency previously assigned for the tournament. This in order

not to harm the team that is going to support or assist in such emergency. Therefore, it is stipulated that no boat may be within 10 meters (33 feet) of another boat. Failure to comply with this rule will result in automatic disqualification from the tournament, thus losing any chance of participating for any prize or any Jackpot.

It will only be allowed to be less than 10 meters (33 feet) at the time of catching live bait, as long as this is in a single point where the boats are forced to be less than 10 meters from each other, the time which this rule may be applied will be 1 hour maximum, after the starting shot.

#### **26.-Fishing limits**

The fishing limit for this tournament will be a radius of 60 nautical miles from the starting marina.

#### **27.-Cancellation of the tournament**

THE ORGANIZING COMMITTEE together with the authorities of the Naval Sector and Port Captancy may cancel one or two days of fishing if, in their opinion, the sea conditions are NOT safe.

Leaving the possibility that THE ORGANIZING COMMITTEE sets a new date for the tournament if the conditions allow it, as well as the viability and cost of it are favorable for THE ORGANIZING COMMITTEE.

In the event that the maritime authorities cancel only one of the two days of fishing, the tournament awards will be adjusted only to the fishing day authorized. In case of the Jackpot, the accumulated amount of the canceled fishing day will be added to the effective fishing day authorized.

#### **28.-Refund for tournament cancellation**

Any cancellation of the tournament due to weather conditions or natural forces would be beyond the control of THE ORGANIZING COMMITTEE of the tournament, so the registration fee will not be refunded. In case of having entered in any or all of the Jackpot categories, these will be returned in cash two business days after the event has concluded at the offices of THE ORGANIZING COMMITTEE. In the event that the participant has had to leave the city due to an emergency or for any other reason, they must go to the offices of THE ORGANIZING COMMITTEE to collect their contribution of Jackpots no later than a period of 30 calendar days, otherwise the corresponding amount will go to the funds of THE ORGANIZING COMMITTEE.

### **29.-Refund if there are no qualified specimens**

In the event that there are no qualified specimens to compete for the prizes or Jackpots, only the Jackpot's money will be returned according to the indications of point number 28 of this regulation. The registration fee will NOT be refunded.

### **30.-Disputes and protests**

Any team that has any disagreement or detects any irregularity committed by any participant from another team, must report it personally with clear evidence to support their complaint, submitted in writing on the official protest format assigned by THE OFFICIAL COMMITTEE and signed no later than 30 minutes after the scale closes, accompanied by a deposit of \$10,000 pesos or \$600 USD. THE SCALE JUDGE and THE ORGANIZING COMMITTEE that will be constituted for this purpose, will have the obligation to carry out the pertinent investigations and, depending on the case, sanction the fault before the awards ceremony.

If the complaint is successful, the deposit will be refunded. At the time of the verification of the digital files that will be presented as evidence, the following must be present: THE SCALE JUDGE, the representative of the non-conforming team and the representative of the team indicated responsible for the fault. THE SCALE JUDGE will prepare a document resolving the protest, which must have the autograph signatures of the participants.

The lack of signatures of the non-conforming team or the team pointed, in no way annuls the decision.

In the event that the complaint is NOT valid, the non-conforming team will lose their made deposit, this with the intention of avoiding improper or non-existent complaints.

### **31.-Safety at sea**

By order of the Secretariat of Communications and Transport (S.C.T.), Port Authority and SEMAR as well as for your own safety, it is mandatory to bring on board the boat all the safety equipment required.

The VHF radio must be turned on and tuned at all times to the previously assigned frequency, which is authorized for all tournaments.

The participating teams must refrain from misusing the radio communication equipment in the understanding that the participants who are identified misusing the radio will be severely penalized by the competent authorities as well as by THE ORGANIZING COMMITTEE of the tournament.

### **32.-Responsive**

THE ORGANIZING COMMITTEE will have a surveillance boat for support and assistance; however, it is not responsible for any accident that the competing teams have before, during and after the tournament, therefore, the participating teams and fishermen together with their boats will enter the competition at their own risk.

### **33.- Determination of disqualification and possible sanctions**

The disqualification or possible sanctions can only be decreed by THE SCALE JUDGE and by THE ORGANIZING COMMITTEE.

### **34.- Reasons for disqualification**

Regardless of the sanctions mentioned in this regulation, any of the faults describes below will be grounds for automatic disqualification and will leave the teams and their individual members out the competition:

- (1) Contravene the foundations, tournament rules and provisions written in these regulations.
- (2) Rest the rod in the rod holders of the boat at the time of capture.
- (3) Present the fish in a state of decomposition or with signs of having been frozen days before the tournament.
- (4) Allow people not registered in the tournament to fish on the boat.
- (5) Fishing freehand, namely without rod and reel, symbol of the sport fisherman.
- (6) Fishing with electric, hydraulic or any type of assisted reels
- (7) Present unsportsmanlike conduct.
- (8) Present to the scale any fish not caught by the same team, whether it has been caught by another boat, by people not registered in the tournament, or has been acquired in any other way.
- (9) Other causes not contemplated, which due to their seriousness, at the discretion of THE SCALE JUDGE and/or THE ORGANIZING COMMITTEE, go against the sporting spirit of fishing.
- (10) Due to a complaint from one of the teams against another.
- (11) For being fishing less than 3 nautical miles from the tuna pens.
- (12) For being within 10 meters (33 feet) of another boat during the battle with any capture.
