Our business developed our action plan and sustainability strategy. Part of the initiatives implemented was to build on our existing packaging database and obtain information from our respective suppliers and locations. Other initiatives that we've implemented were swapping from paper business cards (high min quantities) to Bamboo NFC / QR code Business Cards. Our Cellar Doors have also switched to biodegradable cleaning and sanitising products. All our initiatives in-progress and achieved initiatives have been recorded in our sustainable initiatives tracker.

Criteria 1:

Criteria 4:

Recoverability:

Disposal Labelling:

This criteria considers the extent to which packaging has been labelled to help consumers determine what to do with packaging at end-of-life.

As packaging is updated or refreshed, add on-pack information for consumers on recyclability or correct disposal.

Criteria 6:

On-site Waste:

This criteria considers progress in increasing the amount of on-site solid waste being diverted from landfill.

Develop a system to collect and recycle used packaging generated at our facilities.

Criteria 7:

Problematic Materials:

This criteria considers the extent to which organisations are actively phasing out problematic and unnecessary single-use plastic packaging and preventing/reducing litter.

Undertake the following to help reduce the impact of litter:





- - Conduct regular clean-ups on-site

- Look for opportunities to redesign packaging to eliminate components that may have the 0 propensity to become litter
- Our vineyards have a waste management program and internal warehouse have a cardboard/paper recycling collection with Veolia. Our Sydney and Melbourne Cellar Doors send our glass bottles to recycle via compact glass collection machines and have a commercial waste collection service. External bottlers have their respective waste collection systems along with recycling bins/skips.
