# **SECTION 5. Firefighting measures.**

# 5.1. Extinguishing media.

#### SUITABLE EXTINGUISHING EQUIPMENT

Extinguishing substances are: carbon dioxide, foam, chemical powder. For product loss or leakage that has not caught fire, water spray can be used to disperse flammable vapours and protect those trying to stem the leak.

#### UNSUITABLE EXTINGUISHING EQUIPMENT

# 7.1. Precautions for safe handling.

Keep away from heat, sparks and naked flames; do not smoke or use matches or lighters. # 8.2. Exposure controls.
