

Terms of Use Policy

Welcome to the Asili Malaysia, Always Remember Sdn Bhd and affiliates ("Asili, we, us, or our") website(s) ("Site" (as defined below)), or mobile or handheld device application ("Mobile App(s)" (as defined below)). The Terms of Use ("Policy") is an agreement between Asili and the user ("you, your, user, Customer or Ambassador"), and sets forth the legal terms and conditions governing your use of this Site or Mobile App and purchase/or use of our goods, or services.
