An officer, or manager at United Plumbing & Fire Supply must sign the preliminary lien notice release it receives from United Plumbing & Fire Supply as follows:

- 1.) One check shall be a joint check payable to United Plumbing & Fire Supply and subcontractor for the amount specified in United Plumbing & Fire Supply's preliminary lien notice release.
- 2.) The second check should be a single party check payable to the subcontractor for work performed before the date of United Plumbing & Fire Supply's preliminary lien notice release.

The parties understand and agree that the subcontractor is an independent contractor and is not the agent, partner of joint venture of General Contractor of United Plumbing & Fire Supply. In the even of any dispute relating to this agreement, the successful party shall be entitle to reasonable attorney's fees. The subcontractor hereby appoints United Plumbing & Fire Supply as its Attorney in Fact to sign its endorsement to the back of any jointly payable checks received from the General Contractor.

This agreement shall be binding upon and insure to the benefits of the parties hereto and their respective heirs, executors, administrators, legal representa-tives, successors, and their respective heirs, executors, administrators, legal representatives, successors, and assigns where permitted by this agreement.
