### 2024 Sonoma County Fair Livestock Exhibitor Golf Cart Use and Safety Rules

# To ensure the safety of SCF guests and employees, the following rules apply at all times while on Fair Property.

- 1. Permits will be issued to golf carts only. No ATV, UTV, side by side, or any ranch/utility vehicles with high horsepower allowed. Final determinations of vehicle eligibility will be made by fair staff.
- 2. The permit fee for approved applications is \$200.00.
- 3. All golf carts used on the fairgrounds during the Fair must display a permit issued by the Fair and a signed copy of these rules.
- 4. Permits will be checked out only to the individual listed on this form. No other person is allowed to operate or use the vehicle at any time while it is on the fairgrounds. Permits will not be issued to junior exhibitors, and junior exhibitors may not operate the vehicle.
- 5. Vehicles to be driven onto the Fairgrounds must have proof of insurance on file with your application. Permits will be issued only after proof of liability insurance is provided.
- 6. Attach a doctor's note or copy of disabled person permit to cart.
- The maximum speed limit is 5 MPH. Drivers must obey all posted traffic signage. Pedestrians and livestock always have the right-of-way. Be courteous in asking fairgoers to clear a path. DO NOT HONK AT FAIRGOERS!
- 8. The maximum number of people that may ride on a golf cart at one time is dependent on the number of seats available. One rider per seat. All riders on a golf cart must remain seated at all times.
- 9. All roadways on the Fairgrounds are fire lanes. Any vehicle parked in or blocking a fire lane is subject to being towed at the owner's expense.
- 10. Golf carts approved through the Entry Office may only access the livestock area of the fairgrounds. No vehicles are allowed past the North end of the sheep barn.
- 11. Golf carts are to be used for Fair business only and their use should be kept to a minimum. Joy riding is expressly forbidden.
- 12. Vehicle usage on the Fairgrounds is a privilege regulated by SCF and may be revoked in the event of policy violation(s). SCF shall have sole discretion in determining and/or limiting the use of vehicles on the Fairgrounds. In the event of a violation of these rules, SCF may impose a \$150 penalty (per violation) and/or revoke the privilege of operating a vehicle on the Fairgrounds.
- 13. When parking a golf cart, be sure that entrances to buildings and pedestrian walkways are not impeded.
- 14. Take the key out of the golf cart when you park.
- 15. All vehicle operators must be 18 years old and have a valid driver's license on their person and must abide by all instructions from SCF personnel regarding vehicle operation on the Fairgrounds. The person approved for the golf cart permit should be the only person driving the cart. Children are prohibited from driving golf carts on the Sonoma County Fairgrounds.
- 16. All cart licensees must abide by any instructions from SCF management regarding cart usage on the grounds.

# Livestock Exhibitor Golf Cart License Procedures

• Before a cart may be brought onto the grounds, a license application must be completed and approved by SCF Fair management. If the application is approved, the cart must be brought to the maintenance office for inspection before issuance of a license that allows use of the cart. Any cart that works without a key, has a faulty parking brake, non-working headlights or is deemed unsafe for any other reason, must be repaired prior to being used. Otherwise, it must be removed immediately from the grounds or SCF will impound it for the duration of the Fair.

• There is a fee per cart for a License. No cart may be used on the grounds until the License is affixed to both the front and rear of the cart, and all other permits or numbers from other fairs are removed or covered. Please check with the Fair management on when to submit Golf Cart or Utility Vehicle License Application.

• Every cart shall have a 6-foot fiberglass aerial with an orange (bicycle type) flag attached prior to use on the Fairgrounds.

• SCF reserves the right to amend or modify these rules and regulations as needed. Cart usage is a licensed privilege regulated by SCF management and can be revoked without any refund of permit fees for violation of the rules. SCF management shall have sole discretion to determine the use and limits of carts on the Fairgrounds. In the event of a violation of these cart rules, management may, in its sole discretion, revoke the License to operate a cart and either impound or remove the cart from the Fairgrounds for the remainder of Fair.

1st violation - is a warning

2nd violation - cart is impounded for 24 hours

3rd violation - cart permit is revoked.

NOTE: Golf carts and Utility Vehicles are described as low speed vehicles with 4 or more wheels designed for the purpose of moving people and goods. Any unit exceeding 15 horsepower will be highly scrutinized by Fair Management. Recreational vehicles such as <u>Side by Side</u> type sport vehicles are strictly prohibited and will not be licensed by the Fair in its discretion. 2 wheel gas or electric powered vehicles are not allowed. ADA exceptions may apply to all rules and regulations.
